## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the authority of certain counties to impose a hotel 3 occupancy tax. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Section 352.002(a), Tax Code, is amended to read as follows: 6 (a) The commissioners courts of the following counties by 7 the adoption of an order or resolution may impose a tax on a person 8 9 who, under a lease, concession, permit, right of access, license, contract, or agreement, pays for the use or possession or for the 10 right to the use or possession of a room that is in a hotel, costs \$2 11 12 or more each day, and is ordinarily used for sleeping: 13 (1) a county that has a population of more than 3.3 14 million; (2) a county that has a population of 90,000 or more, 15 16 borders the United Mexican States, and does not have four [three] or more cities that each have a population of more than 25,000 17 $[\frac{17,500}{3}];$ 18 (3) a county in which there is no municipality; 19 20 (4) a county in which there is located an Indian reservation under the jurisdiction of the United States government; 21 22 (5) a county that has a population of 30,000 or less, 23 that has no more than one municipality with a population of less than 2,500, and that borders two counties located wholly in the 24

5 SECTION 2. This Act takes effect immediately if it receives 6 a vote of two-thirds of all the members elected to each house, as 7 provided by Section 39, Article III, Texas Constitution. If this 8 Act does not receive the vote necessary for immediate effect, this 9 Act takes effect September 1, 2017.
