Section 8228.003(c), Special District Local Laws 6 7 Code, as effective April 1, 2017, is amended to read as follows: (c) The creation of the district is essential to accomplish 8 9 the purposes of: (1) a municipal utility district as provided by 10 11 general law and Section 59, Article XVI, Texas Constitution; and 12 (2) Section 52, Article III, Texas Constitution, that relate to the construction, acquisition, improvement, operation, 13 14 or maintenance of macadamized, graveled, or paved roads, or improvements, including storm drainage, in aid of those roads. 15 16 SECTION 2. Subchapter C, Chapter 8228, Special District 17 Local Laws Code, as effective April 1, 2017, is amended by adding Sections 8228.102 and 8228.103 to read as follows: 18 Sec. 8228.102. AUTHORITY FOR ROAD PROJECTS. Under Section 19 52, Article III, Texas Constitution, the district may design, 20 acquire, construct, finance, issue bonds for, improve, operate, 21 maintain, and convey to this state, a county, or a municipality for 22 23 operation and maintenance macadamized, graveled, or paved roads, or improvements, including storm drainage, in aid of those roads. 24

(a) A road project must meet all applicable construction standards, zoning and 2 3 subdivision requirements, and regulations of each municipality in whose corporate limits or extraterritorial jurisdiction the road 4 5 project is located. 6 (b) If a road project is not located in the corporate limits 7 or extraterritorial jurisdiction of a municipality, the road project must meet all applicable construction standards, 8 subdivision requirements, and regulations of each county in which 9 10 the road project is located. (c) If the state will maintain and operate the road, the 11 Texas Transportation <u>Commission must approve the plans</u> 12 and specifications of the road project. 13 14 SECTION 3. Chapter 8228, Special District Local Laws Code, 15 as effective April 1, 2017, is amended by adding Subchapter D to read as follows: 16 17 SUBCHAPTER D. BONDS Sec. 8228.151. BONDS FOR ROAD PROJECTS. At the time of 18 19 issuance, the total principal amount of bonds or other obligations issued or incurred to finance road projects and payable from ad 20 valorem taxes may not exceed one-fourth of the assessed value of the 21 real property in the district. 22 SECTION 4. (a) The legal notice of the intention to 23 24 introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a 25 26 copy of this Act have been furnished to all persons, agencies,

under Section 59, Article XVI, Texas Constitution, and Chapter 313,
Government Code.

3 (b) The governor, one of the required recipients, has 4 submitted the notice and Act to the Texas Commission on 5 Environmental Quality.

6 (c) The Texas Commission on Environmental Quality has filed 7 its recommendations relating to this Act with the governor, the 8 lieutenant governor, and the speaker of the house of 9 representatives within the required time.

10 (d) All requirements of the constitution and laws of this 11 state and the rules and procedures of the legislature with respect 12 to the notice, introduction, and passage of this Act are fulfilled 13 and accomplished.

SECTION 5. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2017.
