H.B. No. 1782

A BILL TO BE ENTITLED

1 AN ACT

2 relating to installment payments of ad valorem taxes.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

4 SECTION 1. Section 31.031(a), Tax Code, as amended by
5 Chapters 122 (H.B. 97), 643 (H.B. 709), and 935 (H.B. 1597), Acts of
6 the 83rd Legislature, Regular Session, 2013, is reenacted to read
7 as follows:

8 (a) This section applies only to:

9 (1) an individual who is:

10 (A) disabled or at least 65 years of age; and

11 (B) qualified for an exemption under Section
12 11.13(c); or

13 (2) an individual who is:

14 (A) a disabled veteran or the unmarried surviving
15 spouse of a disabled veteran; and

16 (B) qualified for an exemption under Section
17 11.132 or 11.22.

18 SECTION 2. Section 31.032, Tax Code, is amended by amending
19 Subsection (b) and adding Subsection (b-1) to read as follows:

20 (b) A person may pay a taxing unit's taxes imposed on
21 property that the person owns in four equal installments without
22 penalty or interest if the first installment is paid [If,] before
23 the delinquency date and is [~~a person pays at least one-fourth of a~~
24 ~~taxing unit's taxes imposed on property that the person owns,~~]

1 accompanied by notice to the taxing unit that the person will pay
2 the remaining taxes in [~~installments, the person may pay the~~
3 ~~remaining taxes without penalty or interest in~~] three equal
4 installments. If the delinquency date is February 1, the second
5 [~~first~~] installment must be paid before April 1, the third [~~second~~]
6 installment must be paid before June 1, and the fourth [~~third~~]
7 installment must be paid before August 1. If the delinquency date
8 is a date other than February 1, the second [~~first~~] installment must
9 be paid before the first day of the second month after the
10 delinquency date, the third [~~second~~] installment must be paid
11 before the first day of the fourth month after the delinquency date,
12 and the fourth [~~third~~] installment must be paid before the first day
13 of the sixth month after the delinquency date.

14 (b-1) Notwithstanding the deadline prescribed by Subsection
15 (b) for payment of the first installment, a person to whom this
16 section applies may pay the taxes in four equal installments as
17 provided by Subsection (b) if the first installment is paid and the
18 required notice is provided before the first day of the first month
19 after the delinquency date.

20 SECTION 3. This Act applies only to ad valorem taxes imposed
21 for a tax year beginning on or after the effective date of this Act.

22 SECTION 4. This Act takes effect January 1, 2018.
