1-16 AN ACT

1-17 relating to general officers within the Texas Military Department.
1-18 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
1-19 SECTION 1. Section 437.058, Government Code, is amended by
1-20 amending Subsections (a), (d), (e), and (f) and adding Subsection
1-21 (d-1) to read as follows:
1-22 (a) The adjutant general may appoint as general officers one
1-23 or more ~~[an]~~ assistant deputy adjutants ~~[adjutant]~~ general for
1-24 army, an assistant deputy adjutant general for air, an assistant
1-25 ~~[deputy]~~ adjutant general for homeland security, and an assistant
1-26 ~~[deputy]~~ adjutant general for domestic operations ~~[government~~
1-27 ~~affairs]~~.
1-28 (d) The assistant deputy adjutants ~~[adjutant]~~ general for
1-29 ~~[the]~~ army shall support the deputy adjutant general for ~~[the]~~
1-30 army, represent the command staff at events as needed, and manage
1-31 the activities assigned by the adjutant general or the deputy
1-32 adjutant general for ~~[the]~~ army.
1-33 (d-1) The assistant deputy adjutant general for air shall
1-34 support the deputy adjutant general for air, represent the command
1-35 staff at events as needed, and manage the activities assigned by the
1-36 adjutant general or the deputy adjutant general for air.
1-37 (e) The assistant ~~[deputy]~~ adjutant general for homeland
1-38 security ~~[the Army National Guard or the Air National Guard]~~, as
1-39 determined by the adjutant general, shall:
1-40 (1) coordinate with other state agencies in matters
1-41 pertaining to homeland security ~~[to ensure state emergency services~~
1-42 ~~are provided and organized to support the state operations center]~~;

1-44 (2) coordinate homeland security actions taken by the

1-46 (f) The assistant ~~[deputy]~~ adjutant general for domestic
