- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Chapter 823, Health and Safety
- 6 Code, is amended to read as follows:
- 7 CHAPTER 823. ANIMAL SHELTERS AND RELEASING AGENCIES
- 8 SECTION 2. Section 823.001, Health and Safety Code, is
- 9 amended by adding Subdivision (5) to read as follows:
- 10 (5) "Releasing agency" has the meaning assigned by
- 11 Section 828.001.
- 12 SECTION 3. Section 823.002, Health and Safety Code, is
- 13 amended to read as follows:
- 14 Sec. 823.002. EXEMPTION FOR CERTAIN COUNTIES, CLINICS, AND
- 15 FACILITIES. Except as provided by Sections 823.003(e) and 823.010,
- 16 this [This] chapter does not apply to:
- 17 (1) a county having a population of less than 75,000;
- 18 (2) a veterinary medicine clinic; or
- 19 (3) a livestock commission facility.
- SECTION 4. Section 823.003(e), Health and Safety Code, is

- (e) The executive commissioner of the Health and Human
- 23 Services Commission shall [may] require each person operating an
- 24 animal shelter or releasing agency to keep records as required by

Section 823.010. The executive commissioner may require the 1 shelter or agency [of the date and disposition of animals in its 2 3 custody,] to maintain the records on the business premises of the [animal] shelter or agency $[\tau]$ and to make the records available for 4 5 inspection at reasonable times. 6 SECTION 5. Chapter 823, Health and Safety Code, is amended 7 by adding Section 823.010 to read as follows: 8 Sec. 823.010. INTAKE AND DISPOSITION RECORDS FOR ANIMAL SHELTERS AND RELEASING AGENCIES. (a) Each animal shelter, 9 including a shelter operated by a municipality, or releasing agency 10 operated in this state shall prepare and maintain records on the 11 12 intake and disposition of animals in the care of the shelter or agency, including: 13 14 (1) the total number of live animals taken in by the 15 shelter or agency, categorized by: 16 (A) species, as dog, cat, or other; and 17 (B) age, as up to five months or adult; (2) the reason an animal was taken in by the shelter or 18 19 agency, including whether the animal was: 20 (A) surrendered by the animal's owner;

17	(E) was euthanized by the shelter or agency on a
18	decision made by the shelter or agency;
19	(F) was euthanized at the owner's request;
20	(G) was returned to the field as part of a
21	sterilization program; or
22	(H) was lost or stolen while in the shelter's or
23	agency's care.
24	(b) An animal shelter or releasing agency shall monthly
25	prepare the records required by Subsection (a).
26	(c) An animal shelter or releasing agency shall maintain
27	records prepared under Subsection (a) until at least the third

- 1 anniversary of the date the record was prepared.
- 2 (d) An animal shelter or releasing agency shall make the
- 3 records required by this section available to the public by:
- 4 (1) posting the records on the shelter's,
- 5 municipality's, or agency's Internet website; or
- 6 (2) for a shelter, municipality, or agency that does
- 7 not have an Internet website, making the records available in a form
- 8 regularly maintained by the shelter, municipality, or agency for
- 9 inspection and copying.
- SECTION 6. The changes in law made by this Act apply only to
- 11 an animal placed at or disposed of by an animal shelter or releasing
- 12 agency or counted in the shelter's or agency's animal total on or
- 13 after the effective date of this Act.
- SECTION 7. This Act takes effect September 1, 2017.
