4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. The heading to Chapter 823, Health and Safety
6	Code, is amended to read as follows:

- SECTION 4. Section 823.003(e), Health and Safety Code, is

7	(4) the disposition of each animal taken in by the

11	(B) was reclaimed by the animal's owner;
12	(C) died in the shelter or under the care of the

14	(D) was transferred from the shelter or agency;

18	(G) was returned to the field as part of a
19	sterilization program; or

22	(b) An animal shelter or releasing agency shall monthly
23	prepare the records required by Subsection (a).
24	(c) An animal shelter or releasing agency shall maintain
25	records prepared under Subsection (a) until at least the third
26	anniversary of the date the record was prepared.
27	(d) An animal shelter or releasing agency shall make the

- 1 records required by this section available to the public by:
- 2 (1) posting the records on the shelter's or agency's
- 3 <u>Internet website; or</u>
- 4 (2) for a shelter or agency that does not have an
- 5 Internet website, making the records available in a form regularly
- 6 maintained by the shelter or agency for inspection and copying.
- 7 SECTION 6. The changes in law made by this Act apply only to
- 8 an animal placed at or disposed of by an animal shelter or releasing
- 9 agency or counted in the shelter's or agency's animal total on or
- 10 after the effective date of this Act.
- 11 SECTION 7. This Act takes effect September 1, 2017.
