- 18 (a) The members of the board are <u>elected</u> [appointed] as
- 19 follows:
- 20 (1) one director is elected from each of the four
- 21 county commissioners precincts by the voters of the applicable
- 22 precinct to be designated as the director whose place number
- 23 matches the applicable precinct number [the Commissioners Court of
- 24 Montgomery County shall appoint two directors];

1	(2) one director is elected by the voters of the
2	district at large to be designated as the director for place number
3	<pre>five;</pre>
4	(3) one director is elected from the City of Conroe by
5	the voters of that municipality; and
6	(4) one director is elected from The Woodlands
7	Township by the voters of that township [the board of directors of
8	the Montgomery County Soil and Water Conservation District shall
9	appoint one director;
10	(3) the board of directors of the San Jacinto River
11	Authority shall appoint one director;
12	[(4) the mayor of the City of Conroe shall appoint one

14	[(5) the mayors of all of the incorporated
15	municipalities, other than the City of Conroe, located in whole or
16	in part in Montgomery County, jointly shall appoint one director;
17	[(6) the board of trustees of the Woodlands Joint
18	Powers Agency shall appoint one director;
19	[(7) the boards of directors of all of the municipal
20	utility districts located in whole or in part in Montgomery County
21	that are not members of the Woodlands Joint Powers Agency and the
22	district boundaries of which are located primarily to the east of
23	Interstate Highway 45 jointly shall appoint one director; and
24	[(8) the boards of directors of all of the municipal
25	utility districts located in whole or in part in Montgomery County
26	that are not members of the Woodlands Joint Powers Agency and the
27	district boundaries of which are located primarily to the west of

- 2 SECTION 4. Chapter 1321, Acts of the 77th Legislature,
- 3 Regular Session, 2001, is amended by adding Section 7A to read as
- 4 follows:
- 5 Sec. 7A. TEMPORARY PROVISION. (a) A director of the board
- 6 of the Lone Star Groundwater Conservation District who is serving
- 7 on August 31, 2017, shall serve until the director's successor has
- 8 qualified following the directors' election held on the uniform
- 9 election date in November 2018.
- 10 (b) After the November 2018 election, the precinct 1
- 11 director, the at-large director, and the director elected by the
- 12 City of Conroe shall serve a term that expires December 1 of the
- 13 second year after the date of the election and the directors of
- 14 precincts 2, 3, and 4 and the director elected by The Woodlands
- 15 Township shall serve a term that expires December 1 of the fourth
- 16 year after the date of that election. The initial two-year terms of
- 17 the precinct 1 director, the at-large director, and the director
- 18 elected by the City of Conroe do not count toward the term
- 19 limitation provided by Section 6(c) of this Act.
- 20 (c) This section expires September 1, 2024.
- SECTION 5. Sections 7(b), (c), and (d), Chapter 1321, Acts
- 22 of the 77th Legislature, Regular Session, 2001, are repealed.
- 23 SECTION 6. (a) The legal notice of the intention to
- 24 introduce this Act, setting forth the general substance of this
- 25 Act, has been published as provided by law, and the notice and a
- 26 copy of this Act have been furnished to all persons, agencies,
- 27 officials, or entities to which they are required to be furnished
