6	SECTION 1. Subchapter C, Chapter 256, Occupations Code, is
7	amended by adding Section 256.1017 to read as follows:
8	Sec. 256.1017. MILITARY LIMITED VOLUNTEER LICENSE. (a)
9	The board shall adopt rules relating to the issuance of a military
10	limited volunteer license under this section.
11	(b) The board may issue a military limited volunteer license
12	to practice dentistry to a dentist or a military limited volunteer
13	license to practice dental hygiene to a dental hygienist who:
14	(1) is licensed and in good standing, or was licensed
15	and retired in good standing, as a dentist or dental hygienist in
16	another state;
17	(2) is or was authorized as a dentist or dental
18	hygienist to treat personnel enlisted in a branch of the United
19	States armed forces or veterans; and
20	(3) meets any other requirement prescribed by board
21	<u>rule.</u>
22	(c) The board may not issue a license under this section to
23	an applicant who:
24	(1) holds a dental or dental hygienist license that:

1	(A) is currently under active investigation; or		
2	(B) is or was subject to a disciplinary order or		
3	action or to denial by another jurisdiction;		
4	(2) holds a license to prescribe, dispense,		
5	administer, supply, or sell a controlled substance that:		
6	(A) is currently under active investigation; or		
7	(B) is or was subject to a disciplinary order or		
8	action or to denial by another jurisdiction; or		
9	(3) has been convicted of, is on deferred adjudication		
10	community supervision or deferred disposition for, or is under		
11	active investigation for the commission of:		
12	(A) a felony; or		
13	(B) a misdemeanor involving moral turpitude.		
14	(d) A dentist or dental hygienist may practice dentistry or		
15	dental hygiene under a license issued under this section only at a		
16	clinic that primarily treats indigent patients. The dentist or		
17	dental hygienist may not receive compensation for dental or dental		
18	hygiene services rendered at the clinic.		
19	(e) A military limited volunteer license holder is subject		
20	to board rules, including rules regarding disciplinary action,		
21	license registration and renewal, and continuing education.		
22	SECTION 2. This Act takes effect September 1, 2017.
