1-17 A BILL TO BE ENTITLED  
 1-18 AN ACT

1-19 relating to quorum and voting requirements for the transaction of  
 1-20 business by the board of the Irving Flood Control District Section  
 1-21 III of Dallas County.

1-22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-23 SECTION 1. Subchapter B, Chapter 7805, Special District  
 1-24 Local Laws Code, is amended by adding Section 7805.054 to read as  
 1-25 follows:

1-26 Sec. 7805.054. QUORUM; VOTE REQUIRED. A quorum consists of  
 1-27 three directors. An action or recommendation of the board  
 1-28 requiring a vote of the board is not valid unless:

1-29 (1) the action or recommendation is approved by a  
 1-30 record vote taken at a meeting of the board with a quorum present;  
 1-31 and

1-32 (2) the action or recommendation receives at least  
 1-33 three affirmative votes by board members.

1-34 SECTION 2. (a) All governmental and proprietary actions  
 1-35 and proceedings of the Irving Flood Control District Section III of  
 1-36 Dallas County taken before the effective date of this Act are  
 1-37 validated, ratified, and confirmed in all respects as of the dates  
 1-38 on which they occurred.

1-39 (b) This section does not apply to any matter that on the  
 1-40 effective date of this Act:

1-41 (1) is involved in litigation if the litigation  
 1-42 ultimately results in the matter being held invalid by a final court  
 1-43 judgment; or

1-44 (2) has been held invalid by a final court judgment.

1-45 SECTION 3. This Act takes effect immediately if it receives  
 1-46 a vote of two-thirds of all the members elected to each house, as  
 1-47 provided by Section 39, Article III, Texas Constitution. If this  
 1-48 Act does not receive the vote necessary for immediate effect, this  
 1-49 Act takes effect September 1, 2017.
