4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 25.025(a), Tax Code, is amended to read
6	as follows:
7	(a) This section applies only to:
8	(1) a current or former peace officer as defined by
9	Article 2.12, Code of Criminal Procedure;

- 11 Occupations Code;
- 12 (3) an employee of the Texas Department of Criminal
- 13 Justice;
- 14 (4) a commissioned security officer as defined by
- 15 Section 1702.002, Occupations Code;
- 16 (5) a victim of family violence as defined by Section
- 17 71.004, Family Code, if as a result of the act of family violence
- 18 against the victim, the actor is convicted of a felony or a Class A
- 19 misdemeanor;
- 20 (6) a federal judge, a state judge, or the spouse of a
- 21 federal judge or state judge;
- 22 (7) a current or former employee of a district
- 23 attorney, criminal district attorney, or county or municipal
- 24 attorney whose jurisdiction includes any criminal law or child

- 1 protective services matters;
- 2 (8) an officer or employee of a community supervision
- 3 and corrections department established under Chapter 76,
- 4 Government Code, who performs a duty described by Section 76.004(b)
- 5 of that code;
- 6 (9) a criminal investigator of the United States as
- 7 described by Article 2.122(a), Code of Criminal Procedure;
- 8 (10) a police officer or inspector of the United
- 9 States Federal Protective Service;
- 10 (11) a current or former United States attorney or
- 11 assistant United States attorney and the spouse and child of the
- 12 attorney;
- 13 (12) a current or former employee of the office of the
- 14 attorney general who is or was assigned to a division of that office
- 15 the duties of which involve law enforcement;
- 16 (13) a medical examiner or person who performs
- 17 forensic analysis or testing who is employed by this state or one or
- 18 more political subdivisions of this state;
- 19 (14) a current or former member of the United States
- 20 armed forces who has served in an area that the president of the
- 21 United States by executive order designates for purposes of 26
- 22 U.S.C. Section 112 as an area in which armed forces of the United
- 23 States are or have engaged in combat;
- 24 (15) a current or former employee of the Texas
- 25 Juvenile Justice Department or of the predecessors in function of
- 26 the department;
- 27 (16) a current or former juvenile probation or

- 1 supervision officer certified by the Texas Juvenile Justice
- 2 Department, or the predecessors in function of the department,
- 3 under Title 12, Human Resources Code; [and]
- 4 (17) a current or former employee of a juvenile
- 5 justice program or facility, as those terms are defined by Section
- 6 261.405, Family Code; and
- 7 (18) a current or former employee of a state judge.
- 8 SECTION 2. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect September 1, 2017.
