Sections 113.252(a), (b), and (c), Estates Code, 13 14 are amended to read as follows: 15 (a) A multiple-party account is not effective against: 16 an estate of a deceased party to transfer to a (1) 17 survivor: (A) amounts equal to the amounts of estate taxes 18 and expenses charged under Subchapter A, Chapter 124, to the 19 deceased party, P.O.D. payee, or beneficiary of the account; or 20 21 (B) if other assets of the estate are insufficient, amounts needed to pay debts, other taxes, 22 and expenses of administration, including statutory allowances to the 23 24 surviving spouse and minor children[, if other assets of the estate are insufficient]; or 25 (2) the claim of a secured creditor who has a lien on 26 27 the account.

(b) A party, P.O.D. payee, or beneficiary who receives 1 payment from a multiple-party account or causes a payment to be made 2 to another person from a multiple-party account after the death of a 3 deceased party is liable to account to the deceased party's 4 personal representative for amounts the deceased party owned 5 beneficially immediately before the party's death to the extent 6 necessary to discharge the claims, expenses, and charges described 7 8 by Subsection (a) [that remain unpaid after application of the deceased party's estate]. The party, P.O.D. payee, or beneficiary 9 10 is not liable in an amount greater than the amount the party, P.O.D. payee, or beneficiary received or caused to be paid to another 11 12 person from the multiple-party account after the deceased party's 13 death.

Sections 2055 and 12 2056), the frequency and method of determining the distributees' 13 [beneficiaries'] respective interests in the undistributed assets 14 of an estate are in the sole and absolute discretion of the executor 15 The executor may consider all relevant factors, 16 of the estate. 17 including administrative convenience and expense and the interests of the various distributees [beneficiaries] of the estate, to reach 18 a fair and equitable result among distributees [beneficiaries]. 19

10 (a) Not later than the 60th day after [On] the first anniversary of [expiration of 12 months from] the date a personal 11 12 representative qualifies and receives letters testamentary or of administration to administer a decedent's estate under court order, 13 14 unless the court authorizes an extension, the representative shall file with the court an account consisting of a written exhibit made 15 under oath that lists all claims against the estate presented to the 16 17 representative during the 12-month period following the representative's qualification and receipt of letters [covered by 18 the account]. The exhibit must specify: 19

1 (a) Not later than the 60th day after each anniversary of the date a personal representative of the estate of a decedent 2 3 qualifies and receives letters testamentary or of administration to administer the decedent's estate under court order, unless the 4 court authorizes an extension, the [Each personal] representative 5 [of the estate of a decedent] shall [continue to] file an annual 6 account conforming to the essential requirements of Section 359.001 7 8 regarding changes in the estate assets occurring during the 12-month period after [since] the date the most recent previous 9 10 account was filed.

SECTION 32. Section 401.006, Estates Code, is amended to read as follows:

Sec. 401.006. GRANTING POWER OF SALE BY AGREEMENT. 13 In a 14 situation in which a decedent does not have a will, or a decedent's 15 will does not contain language authorizing the personal representative to sell property or contains language that is not 16 17 sufficient to grant the representative that authority, the court may include in an order appointing an independent executor any 18 specific authority regarding the power 19 general or of the 20 independent executor to sell property that may be consented to by the distributees [beneficiaries] who are to receive any interest in 21 the property in the application for independent administration or 22 23 for the appointment of an independent executor or in their consents 24 to the independent administration or to the appointment of an independent executor. The independent executor, in such event, may 25 26 sell the property under the authority granted in the court order without the further consent of those distributees [beneficiaries]. 27

1 SECTION 33. Chapter 405, Estates Code, is amended by adding 2 Section 405.0015 to read as follows: 3 Sec. 405.0015. DISTRIBUTIONS GENERALLY. Unless the will, if any, or a court order provides otherwise, an independent 4 5 executor may, in distributing property not specifically devised that the independent executor is authorized to sell: 6 7 (1) make distributions in divided or undivided 8 interests; 9 (2) allocate particular assets in proportionate or 10 disproportionate shares; (3) value the estate property for the purposes of 11 12 acting under Subdivision (1) or (2); and (4) adjust the distribution, division, or termination 13 14 for resulting differences in valuation.

15 SECTION 34. Sections 405.003(b) and (d), Estates Code, are 16 amended to read as follows:

(b) On the filing of an action under this section, each <u>distributee</u> [beneficiary] of the estate shall be personally served with citation, except for a <u>distributee</u> [beneficiary] who has waived the issuance and service of citation.

21 (d) On or before filing an action under this section, the executor must distribute to 22 independent the distributees [beneficiaries] of the estate any of the remaining assets or 23 24 property of the estate that remains in the independent executor's possession after all of the estate's debts have been paid, except 25 26 for a reasonable reserve of assets that the independent executor may retain in a fiduciary capacity pending court approval of the 27

(b) For purposes of Subsection (a), a person is:

9 (1) considered to be in gestation if insemination or 10 implantation occurs at or before the time of death of the person by 11 which the class is measured; and

12 (2) presumed to be in gestation at the time of death of the person by which the class is measured if the person was born 13 14 before the 301st day after the date of the person's death.

Section 33.001, Estates Code, as amended by 19 SECTION 39. this Act, applies only to an application for the probate of a will 20 or for the granting of letters testamentary or of administration of 21 a decedent's estate that is filed on or after the effective date of 22 this Act. An application for the probate of a will or the granting 23 24 of letters filed before that date is governed by the law in effect on the date the application was filed, and the former law is 25 26 continued in effect for that purpose.

SECTION 40. Section 112.103, Estates Code, as amended by 27

1 this Act, applies only to a proceeding under Subchapter C, Chapter 2 112, Estates Code, commenced on or after the effective date of this 3 Act. A proceeding under that subchapter commenced before that date 4 is governed by the law in effect on the date the proceeding was 5 commenced, and the former law is continued in effect for that 6 purpose.

SECTION 41. Section 113.252(c), Estates Code, as amended by this Act, applies to a proceeding commenced before, on, or after the effective date of this Act, regardless of the date of the decedent's death.

SECTION 42. Section 123.056, Estates Code, as added by this Act, applies to a trust created before, on, or after the effective date of this Act with respect to which the marriage of the settlors is dissolved on or after that date.

15 SECTION 43. Sections 123.151(a) and (b), Estates Code, as 16 amended by this Act, and Section 123.151(c-1), as added by this Act, 17 apply only to a multiple-party account for which the marriage of a 18 party to the account is dissolved on or after the effective date of 19 this Act.

20 SECTION 44. Section 123.151(d-1), Estates Code, as added by 21 this Act, and Section 456.0045, Estates Code, as added by this Act, 22 apply only to a cause of action that accrues on or after the 23 effective date of this Act. 7 SECTION 46. Section 205.001, Estates Code, as amended by 8 this Act, applies to a small estate administration commenced on or 9 after the effective date of this Act, regardless of the date of the 10 decedent's death.

SECTION 47. Section 255.401, Estates Code, as amended by this Act, and Section 112.011, Property Code, as added by this Act, apply to the estate of a decedent who dies before, on, or after the effective date of this Act.

15 SECTION 48. Section 255.451, Estates Code, as amended by 16 this Act, applies only to a petition filed on or after the effective 17 date of this Act. A petition filed before that date is governed by 18 the law in effect on the date the petition was filed, and the former 19 law is continued in effect for that purpose.

SECTION 49. Sections 256.003(b), 257.051(a), and 257.054, 20 Estates Code, as amended by this Act, apply only to an application 21 for the probate of a will or administration of a decedent's estate 22 that is filed on or after the effective date of this Act. 23 An application for the probate of a will or administration of a 24 decedent's estate filed before that date is governed by the law in 25 26 effect on the date the application was filed, and the former law is continued in effect for that purpose. 27

1 SECTION 50. Sections 359.001(a) and 359.002(a), Estates 2 Code, as amended by this Act, apply to an account filed on or after 3 the effective date of this Act, regardless of whether the personal 4 representative was appointed before, on, or after that date.

5 SECTION 51. Section 405.0015, Estates Code, as added by 6 this Act, applies to the administration of the estate of a decedent 7 that is pending or commenced on or after the effective date of this 8 Act.
