- relating to the participation of public state colleges in the Jobs 1-17 1**-**18 and Education for Texans (JET) Grant Program. 1-19

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-20 SECTION 1. Section 134.001(2), Education Code, is amended to read as follows: 1-21

(2) "Public junior college<u>,</u>" [and] "public technical institute<u>,</u>" and "public state college" have the meanings assigned by Section 61.003. 1-22 1-23 1-24

1-25 SECTION 2. Section 134.004, Education Code, is amended to 1-26 read as follows:

Sec. 134.004. JOBS AND EDUCATION FOR TEXANS (JET) GRANT PROGRAM. (a) The commission shall establish and administer the 1-27 1-28 Jobs and Education for Texans (JET) Grant Program to provide grants 1-29 1-30 to public junior colleges, public technical institutes, public state colleges, and independent school districts described under Section 134.007 that apply to the advisory board in the manner prescribed by the advisory board. The commission shall award the 1-31 1-32 1-33 1-34 grants on the advice and recommendations of the advisory board.

Grants may be awarded under this chapter from the Jobs 1-35 (b) 1-36 and Education for Texans (JET) fund to defray the start-up costs associated with the development of new career and technical education programs at public junior colleges, public technical 1-37 1-38 1-39 institutes, public state colleges, and independent school districts described under Section 1-40 134.007 that meet the 1-41 requirements of Section 134.006.
