The alphanumeric pattern 8 for a license plate issued under this subsection may remain on a token trailer for as long as the registration of the token trailer 10 is renewed or until the token trailer is removed from service 11 sold. The registration receipt required under Section 621.002 is 12 not required for a vehicle that displays a license plate issued 13 14 under this subsection]. SECTION 2. The heading to Section 502.255, Transportation 15 Code, is amended to read as follows: 16 Sec. 502.255. - 2 The department shall issue a license plate for a token (i) 3 trailer registered under this section that does not expire or require an annual registration insignia to be valid. The license 4 plate must include the word "Permanent." A [alphanumeric pattern 5 for a] license plate issued under this subsection may remain on a 6 token trailer [for as long as the registration of the token trailer 7 8 is renewed or] until the token trailer is removed from service or sold, provided that the license plate must be removed if the 9 department cancels, suspends, or revokes the registration for the 10 token trailer as provided by law or department rule. 11 The 12 registration receipt required under Section 621.002 is not required for a vehicle that displays a license plate issued under this 13 14 subsection.
- 15 (j) A person may register a semitrailer under this section 16 if the person:
- 17 (1) applies to the department for registration;
- (2) provides proof of the person's eligibility to register the vehicle under this subsection as required by the department; and
- (3) pays the applicable [a] fee required by Subsection (c) [of \$15], plus any other applicable fee under this chapter for each year the semitrailer is registered or at each registration if the semitrailer is registered under Subsection (i) [Section 502.401, for each year included in the registration period].
- SECTION 4. The change in law made by this Act applies only in connection with the registration of a vehicle that is applied for

- 1 on or after the effective date of this Act.
