H.B. No. 2452

A BILL TO BE ENTITLED 1 AN ACT 2 relating to requirements to vote, including presenting proof of 3 identification; providing criminal penalties. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Section 15.022(a), Election Code, is amended to read as follows: 6 7 (a) The registrar shall make the appropriate corrections in the registration records, including, if necessary, deleting a 8 voter's name from the suspense list: 9 (1) after receipt of a notice of a change 10 in 11 registration information under Section 15.021; 12 (2) after receipt of a voter's reply to a notice of 13 investigation given under Section 16.033; 14 (3) after receipt of any affidavits executed under Section 63.007 [63.006], following an election; 15 (4) after receipt of a voter's statement of residence 16 executed under Section 63.0011; 17 (5) before the effective date of the abolishment of a 18 county election precinct or a change in its boundary; 19 20 (6) after receipt of United States Postal Service 21 information indicating an address reclassification; (7) after receipt of a voter's response under Section 22 15.053; or 23 24 (8) after receipt of a registration application or

1 change of address under Chapter 20.

2 SECTION 2. Section 32.114(a), Election Code, is amended to 3 read as follows:

4 The county clerk shall provide one or more sessions of (a) 5 training using the standardized training program and materials developed and provided by the secretary of state under Section 6 32.111 for the election judges and clerks appointed to serve in 7 8 elections ordered by the governor or a county authority. Each election judge shall complete the training program. [Each election 9 10 clerk shall complete the part of the training program relating to the acceptance and handling of the identification presented by a 11 voter to an election officer under Section 63.001. 12

SECTION 3. Sections 63.001(b), (c), (d), and (f), Election
Code, are amended to read as follows:

(b) <u>On</u> [Except as provided by Subsection (h), on] offering to vote, a voter must present <u>the voter's voter registration</u> <u>certificate</u> to an election officer at the polling place [one form of identification described by Section 63.0101].

(c) On presentation of <u>a registration certificate</u> [the 19 documentation required under Subsection (b)], an election officer 20 21 shall determine whether the voter's name on the registration certificate [documentation] is on the list of registered voters for 22 the precinct. [If in making a determination under this subsection 23 24 the election officer determines under standards adopted by the secretary of state that the voter's name on the documentation is 25 26 substantially similar to but does not match exactly with the name on the list, the voter shall be accepted for voting under Subsection 27

(d) if the voter submits an affidavit stating that the voter is the
 person on the list of registered voters.

3 (d) If [, as determined under Subsection (c),] the voter's
4 name is on the precinct list of registered voters [and the voter's
5 identity can be verified from the documentation presented under
6 Subsection (b)], the voter shall be accepted for voting.

7 (f) After determining whether to accept a voter, an election 8 officer shall return the voter's <u>registration certificate</u> 9 [documentation] to the voter.

SECTION 4. Section 63.0011(a), Election Code, is amended to read as follows:

Before a voter may be accepted for voting, an election 12 (a) officer shall ask the voter if the voter's residence address on the 13 precinct list of registered voters is current and whether the voter 14 15 has changed residence within the county. If the voter's address is omitted from the precinct list under Section 18.005(c), the officer 16 17 shall ask the voter if the voter's residence as [, if] listed [,] on the voter's voter registration certificate [identification 18 presented by the voter under Section 63.001(b)] is current and 19 20 whether the voter has changed residence within the county.

21 SECTION 5. Section 63.006, Election Code, is amended to 22 read as follows:

23 Sec. 63.006. VOTER WITH <u>CORRECT CERTIFICATE</u> [REQUIRED 24 DOCUMENTATION] WHO IS NOT ON LIST. (a) A voter who, when offering to 25 vote, presents <u>a voter registration certificate indicating that the</u> 26 <u>voter is currently registered in the precinct in which the voter is</u> 27 <u>offering to vote,</u> [the documentation required under Section

1 63.001(b)] but whose name is not on the precinct list of registered 2 voters, shall be accepted for voting [if the voter also presents a 3 voter registration certificate indicating that the voter is 4 currently registered:

5 [(1) in the precinct in which the voter is offering to 6 vote; or

7 [(2) in a different precinct in the same county as the 8 precinct in which the voter is offering to vote and the voter 9 executes an affidavit stating that the voter:

10 [(A) is a resident of the precinct in which the 11 voter is offering to vote or is otherwise entitled by law to vote in 12 that precinct;

13 [(B) was a resident of the precinct in which the 14 voter is offering to vote at the time the information on the voter's 15 residence address was last provided to the voter registrar;

16 [(C) did not deliberately provide false 17 information to secure registration in a precinct in which the voter 18 does not reside; and

19 [(D) is voting only once in the election].
20 (b) After the voter is accepted, an election officer shall

21 [÷

22 [(1)] indicate beside the voter's name on the poll list 23 that the voter was accepted under this section[; and

24 [(2) enter the voter's name on the registration 25 omissions list].

26 SECTION 6. Chapter 63, Election Code, is amended by adding 27 Sections 63.007 and 63.008 to read as follows:

H.B. No. 2452 1 Sec. 63.007. VOTER WITH INCORRECT CERTIFICATE WHO IS NOT ON 2 LIST. (a) A voter who, when offering to vote, presents a voter registration certificate indicating that the voter is currently 3 registered in a different precinct from the one in which the voter 4 5 is offering to vote, and whose name is not on the precinct list of registered voters, shall be accepted for voting if the voter 6 7 executes an affidavit stating that the voter: 8 (1) is a resident of the precinct in which the voter is offering to vote or is otherwise entitled by law to vote in that 9 10 precinct; (2) was a resident of the precinct in which the voter 11 12 is offering to vote at the time the information on the voter's residence address was last provided to the voter registrar; 13 14 (3) did not deliberately provide false information to 15 secure registration in a precinct in which the voter does not 16 reside; and 17 (4) is voting only once in the election. After the voter is accepted, an election officer shall 18 (b) 19 indicate beside the voter's name on the poll list that the voter was accepted under this section. 20 21 Sec. 63.008. VOTER WITHOUT CERTIFICATE WHO IS ON LIST. (a) A 22 voter who does not present a voter registration certificate when 23 offering to vote, but whose name is on the list of registered voters 24 for the precinct in which the voter is offering to vote, shall be accepted for voting if the voter executes an affidavit stating that 25 26 the voter does not have the voter's voter registration certificate in the voter's possession at the polling place at the time of 27

3	(b) If the requirements prescribed by Subsection (a) are not
4	met, the voter may be accepted for provisional voting only under
5	Section 63.011.
6	SECTION 7. Section 63.009, Election Code, is amended to
7	read as follows:
8	Sec. 63.009. VOTER WITHOUT CERTIFICATE WHO IS NOT ON LIST.
9	(a) Except as provided by Subsection (b), a $[A]$ voter who does not
10	present a voter registration certificate when offering to vote, and
11	whose name is not on the list of registered voters for the precinct
12	in which the voter is offering to vote, shall be accepted for
13	provisional voting if the voter executes an affidavit in accordance
14	with Section 63.011.
15	(b) If an election officer can determine from the voter
16	registrar that the person is a registered voter of the county and
17	the person presents proof of identification, the affidavits
18	required by Sections 63.007 and 63.008 are substituted for the
19	affidavit required by Section 63.011 in complying with that
20	section. After the voter is accepted under this subsection, an
21	election officer shall also indicate beside the voter's name on the
22	poll list that the voter was accepted under this section.

23 SECTION 8. Section 63.0101, Election Code, is amended to 24 read as follows:

25 Sec. 63.0101. DOCUMENTATION OF PROOF OF IDENTIFICATION. The 26 following documentation is [an] acceptable <u>as proof</u> [form] of 27 [photo] identification under this chapter:

3	SECTION 9. Sections 63.011(a) and (b), Election Code, are
4	amended to read as follows:
5	(a) A person to whom Section <u>63.008(b) or 63.009(a)</u>
6	[63.001(g) or 63.009] applies may cast a provisional ballot if the
7	person executes an affidavit stating that the person:
8	(1) is a registered voter in the precinct in which the
9	person seeks to vote; and
10	(2) is eligible to vote in the election.
11	(b) A form for an affidavit required by this section must be
12	printed on an envelope in which the provisional ballot voted by the
13	person may be placed and must include[+

No. 2452 [(1)] from the 1 information in the affidavit or contained in public records, the person is eligible to vote in the 2 3 election and has not previously voted in that election [+ 4 [(2) the person: 5 [(A) meets the identification requirements of Section 63.001(b) at the time the ballot was cast or in the period 6 prescribed under Section 65.0541; 7 8 [(B) notwithstanding Chapter 110, Civil Practice and Remedies Code, executes an affidavit under penalty of perjury 9 10 that states the voter has a religious objection to being photographed and the voter has consistently refused to be 11 12 photographed for any governmental purpose from the time the voter has held this belief; or 13 [(C) executes an affidavit under penalty of 14 15 perjury that states the voter does not have any identification meeting the requirements of Section 63.001(b) as a result of a 16 17 natural disaster that was declared by the president of the United States or the governor, occurred not earlier than 45 days before the 18 19 date the ballot was cast, and caused the destruction of or inability to access the voter's identification; and 20 [(3) the voter has not been challenged and voted a 21 provisional ballot solely because the voter did not meet the 22 requirements for identification prescribed by Section 63.001(b)]. 23 24 SECTION 12. Section 66.0241, Election Code, is amended to read as follows: 25 Sec. 66.0241. CONTENTS OF ENVELOPE NO. 4. Envelope no. 4 26

(1) the precinct list of registered voters; 1 the registration correction list; 2 (2) any statements of residence executed under Section 3 (3) 4 63.0011; and (4) 5 any affidavits executed under Section 63.007 6 [63.006] or 63.011. SECTION 13. (a) The following sections of the Election 7 8 Code are repealed: (1) Section 13.002(i); 9 (2) Section 15.001(c); 10 11 (3) Section 15.005; (4) Section 31.012; 12 (5) Section 32.111(c); 13 Section 62.016; 14 (6) 15 (7) Sections 63.001(g) and (h); (8) Section 63.0012; and 16 Section 65.0541. 17 (9) Chapter 521A, Transportation Code, is repealed. 18 (b) SECTION 14.
