(a) The committee is established to plan, oversee, and 20 facilitate annual ceremonies recognizing and honoring peace 21 officers of this state who were killed in the line of duty. 22 23 (b) The committee consists of the following members: 24 (1) a president, or the president's designee, of a law

26	(a) The committee shall meet as necessary to plan and coordinate an
27	annual memorial ceremony on the Capitol grounds to honor Texas

1	peace officers who were killed in the line of duty.
2	(b) The committee shall hold the ceremony on a date selected
3	by the committee during the week in which May 8 occurs.
4	(c) The committee and the organizations represented on the
5	committee shall solicit and accept private donations to fund the
6	ceremony.
7	(d) Each odd-numbered year, the ceremony must include a:
8	(1) parade of law enforcement color guards and
9	personnel ending at the Capitol; and
10	(2) ceremony held during a joint session of the
11	legislature on the floor of the house of representatives, if
12	possible.
13	(e) During the ceremony under Subsection (d)(2), the name of
14	each peace officer who was killed in the line of duty since the
15	previous ceremony under Subsection (d) must be read and the
16	surviving family members of the peace officer must be recognized.
17	SECTION 5. This Act takes effect September 1, 2017.
