- 2 relating to the repeal of certain obsolete laws governing state
- 3 pensions and other similar benefits.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. FINDINGS. The legislature finds that certain
- 6 laws governing state pension and other benefits have become
- 7 obsolete and should no longer be included in the reported statutes
- 8 of this state. These laws consist of:
- 9 (1) part of the enabling legislation for state
- 10 pensions for Confederate veterans and their surviving spouses;
- 11 (2) authorization of a state pension for veterans of
- 12 the Texas Revolution and their surviving spouses;
- 13 (3) authorization of a state pension for certain Texas
- 14 Rangers who served before September 1, 1947, and their surviving
- 15 spouses; and
- 16 (4) several statutes from the 1930s providing
- 17 transitional funding mechanisms and appropriations for the
- 18 original Texas Old Age Assistance Fund.
- 19 SECTION 2. REPEALER. The following provisions are
- 20 repealed:
- 21 (1) Articles 6205, 6208, 6209, 6210, 6211, 6212, 6213,
- 22 6214, 6215, 6217, 6218, 6220, 6221, 6222, 6223, 6224, 6225, 6226,
- 23 and 6227, Revised Statutes;

- 18 SECTION 3. EFFECTIVE DATE. This Act takes effect
- 19 immediately if it receives a vote of two-thirds of all the members
- 20 elected to each house, as provided by Section 39, Article III, Texas
- 21 Constitution. If this Act does not receive the vote necessary for
- 22 immediate effect, this Act takes effect September 1, 2017.
