AN ACT

2 relating to the salary of a bailiff in El Paso County.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

4 SECTION 1. Sections 53.0091(a), (b), and (d), Government 5 Code, are amended to read as follows:

6 Each bailiff appointed under Section 53.002(c) shall be (a) paid an annual salary out of the general fund of El Paso County, 7 unless another source of funding is approved by the commissioners 8 court. The council of judges shall set the salary in writing 9 consistent with pay scales adopted by the commissioners court that 10 are comparable to other positions within El Paso County. [The 11 12 appointing judge shall set the salary in writing, but except as otherwise provided by this section, the annual salary shall be set 13 at \$18,000 on August 26, 1985, and thereafter the \$18,000 annual 14 salary shall increase as provided by Subsection (c). 15

Bailiffs appointed under Section 53.002(c) who held 16 (b) office as bailiffs under that section [Chapter 817, Acts of the 62nd 17 Legislature, Regular Session, 1971 (Article 22921, Vernon's Texas 18 Civil Statutes), or under Chapter 532, Acts of the 67th 19 Legislature, Regular Session, 1981 (Article 22920, Vernon's Texas 20 21 Civil Statutes), on June 30, 2017 [August 25, 1985], are entitled to receive at least the same annual salary or compensation under 22 23 this section as they received [under those Acts] on that date [August 26, 1985]. 24

1 (d) A person appointed to succeed a bailiff who held office as bailiff under Section 53.002(c) [Chapter 817, Acts of the 62nd 2 Legislature, Regular Session, 1971 (Article 22921, Vernon's Texas 3 Civil Statutes), or under Chapter 532, Acts of the 67th 4 Legislature, Regular Session, 1981 (Article 22920, Vernon's Texas 5 Civil Statutes),] is not entitled to be paid the same annual salary 6 paid to the bailiff the person [he] succeeds, but is entitled to 7 8 receive an annual salary as provided by Subsection (a) [the annual salary as provided by this section so that the bailiffs' salaries 9 10 under this section will become uniform with the passage of time. A person appointed to succeed any bailiff before October 1, 1986, is 11 entitled to the \$18,000 annual salary set by Subsection (a). A 12 person appointed to succeed any bailiff on or after October 1, 1986, 13 14 is entitled to the \$18,000 annual salary set by Subsection (a) or 15 the salary set on the date the bailiff is appointed for a Grade 20 of the El Paso County Job Guide Designation for a new employee under 16 17 Grade 20, whichever is greater. A bailiff whose annual salary is set on September 30, 1986, at \$18,000 under this section is on 18 19 October 1, 1986, entitled to any salary increase provided for under Subsection (c) or the salary set on October 1, 1986, for a Grade 20 20 of the El Paso County Job Cuide Designation for a new employee under 21 Grade 20, whichever is greater. After October 1, 1986, all salary 22 increases for bailiffs shall be uniform as provided for in 23 24 Subsection (c). If a substantial number of those job titles or positions listed on the effective date of this section under Grade 25 26 20 of the El Paso County Job Guide Designation are removed from Grade 20 or the El Paso County Job Guide Designation is replaced 27

1 with some other system for setting employees' salaries under those job titles or positions listed under Grade 20 of the El Paso County 2 Job Guide Designation, on the date a new bailiff is appointed, the 3 4 starting salary being paid at that time by El Paso County to the functional equivalent of Grade 20 of the El Paso County Job Guide 5 Designation shall be used in place of Grade 20. In determining the 6 functional equivalent of Grade 20 under this section, the job 7 titles, positions, or their equivalent listed under Grade 20 on 8 August 26, 1985, shall be considered as the only factors]. 9 SECTION 2. Sections 53.0091(c) and (e), Government Code, 10 are repealed. 11
