## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to authorization by the Texas Higher Education
- 3 Coordinating Board for certain public junior colleges to offer
- 4 baccalaureate degree programs.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 130.0012, Education Code, is amended by
- 7 amending Subsections (a), (d), (e), and (g) and adding Subsections
- 8 (b-4), (b-5), (e-1), and (g-1) to read as follows:
- 9 (a) The Texas Higher Education Coordinating Board may
- 10 [shall] authorize public junior colleges to offer baccalaureate
- 11 degree programs in the fields of applied science, [and] applied
- 12 technology, and nursing under this section. Offering a
- 13 baccalaureate degree program under this section does not otherwise
- 14 alter the role and mission of a public junior college.
- 15 (b-4) The coordinating board shall establish a pilot
- 16 project to examine the feasibility and effectiveness of authorizing
- 17 a baccalaureate degree program in the field of nursing to be offered
- 18 by the South Texas Community College District if it has
- 19 <u>demonstrated a workforce need.</u>
- 20 (b-5) Not later than January 1, 2019, the coordinating board
- 21 shall prepare a progress report on the pilot project established
- 22 under Subsection (b-4). Not later than January 1, 2021, the
- 23 coordinating board shall prepare a report on the effectiveness of
- 24 the pilot project, including any recommendations for legislative

- 1 action regarding the offering of baccalaureate degree programs in
- 2 the field of nursing by a public junior college. The coordinating
- 3 board shall deliver a copy of each report to the governor, the
- 4 lieutenant governor, the speaker of the house of representatives,
- 5 and the chair of the standing committee of each house of the
- 6 legislature with primary jurisdiction over higher education.
- 7 Unless the authority to continue offering a baccalaureate degree
- 8 program in the field of nursing is continued by the legislature, a
- 9 public junior college may not:
- 10 <u>(1) enroll a new student in a baccalaureate degree</u>
- 11 program under the pilot project after the 2022 fall semester;
- 12 (2) offer junior-level or senior-level courses for
- 13 those degree programs after the 2025 fall semester, unless the
- 14 coordinating board authorizes the college to offer those courses;
- 15 <u>or</u>
- 16 (3) award a baccalaureate degree under the pilot
- 17 project after the 2025 fall semester, unless the coordinating board
- 18 approves the awarding of the degree.
- 19 (d) A public junior college offering a baccalaureate degree
- 20 program under this section may not offer more than  $\underline{\text{six}}$  [five]
- 21 baccalaureate degree programs at any time. The degree programs are
- 22 subject to the continuing approval of the coordinating board.
- (e) In determining whether a public junior college may offer
- 24 [what] baccalaureate degree programs and what degree programs may
- 25 [are to] be offered, the coordinating board shall:
- 26 (1) apply the same criteria and standards the
- 27 coordinating board uses to approve baccalaureate degree programs at

- 1 general academic teaching institutions; and 2 (2) consider the following factors: 3 (A) [(A)] the workforce need for the degree programs in the region served by the junior college; 4 (B)  $[\frac{(2)}{2}]$  how 5 those degree programs complement the other programs and course offerings of the junior 6 7 college and whether the associate degree program offered by the 8 junior college in the same field has been successful; 9 (C)  $[\frac{(3)}{(3)}]$  whether those degree programs would 10 unnecessarily duplicate the degree programs offered by other institutions of higher education; and 11 12 (D)  $[\frac{4}{1}]$  the ability of the junior college to support the degree programs with student enrollment [program] and 13 14 adequacy of the junior college's facilities, faculty, 15 administration, libraries, and other resources. (e-1) A public junior college may offer a baccalaureate 16 17 degree program under this section only if its junior college
- Except as provided by Subsection (g-1), in  $[\frac{In}{I}]$  its 20 recommendations to the legislature relating to state funding for 21 public junior colleges, the coordinating board shall recommend that 22 a public junior college receive substantially the same state 23 24 support for junior-level and senior-level courses offered under this section as that provided to a general academic teaching 25 26 institution for substantially similar courses. In determining the contact hours attributable to students enrolled in a junior-level 27

or senior-level course offered under this section used to determine 1 junior college's proportionate share 2 public of appropriations under Section 130.003, the coordinating board shall 3 weigh those contact hours as necessary to provide the junior 4 5 college the appropriate level of state support to the extent state funds for those courses are included in the appropriations. This 6 subsection does not prohibit the legislature from directly 7

appropriating state funds to support junior-level and senior-level

courses offered under this section.

- 11 created under Subsection (b-4) is offered, the degree program may
  12 be funded solely by a public junior college's proportionate share
  13 of state appropriations under Section 130.003, local funds, and
  14 private sources. This subsection does not require the legislature
  15 to appropriate state funds to support a degree program under
  16 Subsection (b-4).
- SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2017.
