- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Chapter 42A, Code of Criminal Procedure, is
- 6 amended by adding Subchapter H-1 to read as follows:
- 7 SUBCHAPTER H-1. VETERANS REEMPLOYMENT PROGRAM
- 8 Art. 42A.381. VETERANS REEMPLOYMENT PROGRAM. In this
- 9 subchapter "veterans reemployment program" means a program that
- 10 provides education and training to veterans with the goal that the
- 11 veterans become gainfully employed.

- 12 Art. 42A.382. ELIGIBILITY. (a) A defendant placed on
- 13 <u>deferred adjudication community supervision for or convicted of a</u>
- 14 misdemeanor offense is eligible to participate in a veterans
- 15 reemployment program established under this subchapter if the
- 16 defendant is a veteran of the United States armed forces, including
- 17 <u>a member of the reserves</u>, national guard, or state guard.
- 18 (b) The judge granting community supervision to a defendant
- 19 <u>described</u> by Subsection (a) shall inform the defendant of the
- 20 defendant's eligibility for the program but may not require the
- 21 defendant to participate in the program.
- (c) A judge may additionally impose any condition of
- 23 community supervision that the judge is authorized to impose under
- 24 this chapter on a defendant who chooses to participate in the

- 1 program under this subchapter.
- 2 Art. 42A.383. EDUCATION AND TRAINING COURSES. (a) A
- 3 participant in the program shall diligently attend workforce
- 4 development education and training courses developed or approved by
- 5 the Texas Workforce Commission under Chapter 316, Labor Code, as
- 6 directed by the court.
- 7 (b) The education and training courses under this article
- 8 must focus on providing a participant with useful workplace skills
- 9 most likely to lead to gainful employment by the participant.
- 10 <u>(c) The education and training courses may be</u>
- 11 individualized based on any physical or intellectual limitations of
- 12 the participant.
- 13 Art. 42A.384. COMPLETION OF PROGRAM. A participant
- 14 successfully completes the veterans reemployment program if the
- 15 participant completes the education and training courses required
- 16 by the court and:
- 17 (1) obtains employment and retains that employment for
- 18 three continuous months;
- 19 (2) diligently searches for employment for a
- 20 continuous period of six months; or
- 21 (3) is determined by the court to be unemployable
- 22 <u>because of a disability.</u>
- 23 Art. 42A.385. FAILURE TO COMPLETE PROGRAM. (a) The judge
- 24 may not revoke the community supervision of a defendant who fails to
- 25 complete the program under this subchapter.
- 26 (b) If the defendant fails to complete the program under
- 27 this subchapter, the judge may:

1 (1) modify the defendant's conditions of community 2 supervision; and 3 (2) extend the period of community supervision so that the defendant may comply with the conditions under Subdivision (1). 4 5 SECTION 2. Subchapter E-1, Chapter 411, Government Code, is amended by adding Section 411.0729 to read as follows: 6 7 Sec. 411.0729. PROCEDURE FOR CERTAIN VETERANS. 8 successful completion of the veterans reemployment program created under Subchapter H-1, Chapter 42A, Code of Criminal Procedure, and 9 all other conditions of the defendant's community supervision, 10 regardless of whether the defendant meets the eligibility criteria 11 under this subchapter, after notice to the state and a hearing on 12 whether issuance of an order of nondisclosure is in the best 13 interest of justice, the court shall enter an order of 14 15 nondisclosure with respect to all records of the offense for which the defendant was convicted or placed on deferred adjudication 16 17 community supervision. SECTION 3. Subtitle B, Title 4, Labor Code, is amended by 18 19 adding Chapter 316 to read as follows: CHAPTER 316. VETERANS REEMPLOYMENT EDUCATION AND TRAINING COURSES 20 21 Sec. 316.001. VETERANS REEMPLOYMENT PROGRAM. In this chapter "veterans reemployment program" means the community 22 23 supervision program created under Subchapter H-1, Chapter 42A, Code 24 of Criminal Procedure. - 7 SECTION 4. Not later than January 1, 2018, the Texas
- 8 Workforce Commission shall develop or approve education and
- 9 training courses as required under Chapter 316, Labor Code, as
- 10 added by this Act.
- 11 SECTION 5. Subchapter H-1, Chapter 42A, Code of Criminal
- 12 Procedure, applies only to a person placed on community
- 13 supervision, including deferred adjudication community
- 14 supervision, on or after January 1, 2018.
- 15 SECTION 6. This Act takes effect immediately if it receives
- 16 a vote of two-thirds of all the members elected to each house, as
- 17 provided by Section 39, Article III, Texas Constitution. If this
- 18 Act does not receive the vote necessary for immediate effect, this
- 19 Act takes effect September 1, 2017.
