## A BILL TO BE ENTITLED

1 AN ACT 2 relating to the establishment of a pilot program under which a licensed hospital may offer dual credit courses to public high 3 school students. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 SECTION 1. Subchapter A, Chapter 28, Education Code, is 6 7 amended by adding Section 28.0091 to read as follows: Sec. 28.0091. MEDICAL DUAL CREDIT PILOT PROGRAM. (a) The 8 9 agency shall develop and implement a pilot program under which a licensed hospital may offer dual credit courses to high school 10 students enrolled in a school district in partnership with the 11 district. 12 (b) The agency shall select one licensed hospital to 13 participate in the pilot program. The hospital must be accredited 14 by The Joint Commission and: 15 16 (1) have been issued: (A) a certificate of approval to offer a program 17 of instruction by the Texas Workforce Commission under Subchapter 18 19 C, Chapter 132; or 20 (B) a certificate of authority to award a degree for a program of study by the Texas Higher Education Coordinating 21 Board under Subchapter G, Chapter 61; or 22 23 (2) be accredited to offer a degree program by a 24 recognized accrediting agency, as that term is defined by Section

2	(c) The licensed hospital selected under Subsection (b):
3	(1) may offer under the pilot program only dual credit
4	courses that are in the curriculum of the hospital's authorized
5	program of instruction or study or accredited degree program, as

8	shall determine the content of each dual credit course offered

This Act applies beginning with the 2017-2018 9 school year. SECTION 3. This Act takes effect immediately if it receives 10 a vote of two-thirds of all the members elected to each house, as 11 provided by Section 39, Article III, Texas Constitution. If this 12 Act does not receive the vote necessary for immediate effect, this 13

14 Act takes effect September 1, 2017.
