- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Subsection 21.051 Education Code, is amended to
- 5 read as follows:
- 6 Sec. 21.051. RULES REGARDING FIELD-BASED EXPERIENCE AND
- 7 OPTIONS FOR FIELD EXPERIENCE AND INTERNSHIPS. (a) In this section,
- 8 "teacher of record" means a person employed by a school district who
- 9 teaches the majority of the instructional day in an academic
- 10 instructional setting and is responsible for evaluating student
- 11 achievement and assigning grades.
- 12 (b) Before a school district may employ a candidate for
- 13 certification as a teacher of record, the candidate must complete
- 14 at least 15 hours of field-based experience, which may be obtained
- 15 up to two years prior to, or subsequent to, admission in an educator
- 16 preparation program. These field-based experiences may be obtained
- 17 by observation of a Texas certified teacher in which the candidate
- 18 is actively engaged in instructional or educational activities, or
- 19 by serving as a substitute teacher or teachers aide under
- 20 supervision at:
- 21 (1) at a public school campus accredited or approved
- 22 for the purpose by the agency; or
- 23 (2) at a private school recognized or approved for the
- 24 purpose by the agency.

- 1 (c) Subsection (b) applies only to an initial certification
- 2 issued on or after September 1, 2012. Subsection (b) does not
- 3 affect:
- 4 (1) the validity of a certification issued before
- 5 September 1, 2012; or
- 6 (2) the eligibility of a person who holds a
- 7 certification issued before September 1, 2012, to obtain a
- 8 subsequent renewal of the certification in accordance with board
- 9 rule.
- 10 (d) Subsection (b) does not affect the period within which
- 11 an individual must complete field-based experience hours as
- 12 determined by board rule if the individual is not accepted into an
- 13 educator preparation program before the deadline prescribed by
- 14 board rule and is hired for a teaching assignment by a school
- 15 district after the deadline prescribed by board rule.
- 16 (e) The board shall propose rules relating to the
- 17 field-based experience required by Subsection (b). The
- 18 commissioner by rule shall adopt procedures and standards for
- 19 recognizing a private school under Subsection (b)(2).
- 20 (f) The board shall propose rules providing flexible
- 21 options for persons for any field-based experience or internship
- 22 required for certification.
- 23 SECTION 2. This Act takes effect September 1, 2017.
