- SECTION 2. Title 12, Business & Commerce Code, is amended by

- 23 SERVICES FOR ACTIVE DUTY MILITARY SERVICE MEMBERS
- Sec. 606.001. DEFINITIONS. In this chapter:

12	by Section 66.002, Utilities Code.		
13	(3) "Health spa" has the meaning assigned by Section		
14	702.003, Occupations Code.		
15	(4) "Health spa services" has the meaning assigned to		
16	the term "services" by Section 702.003, Occupations Code.		
17	(5) "Health spa services provider" means a person		
18	providing health spa services.		
19	(6) "Internet service provider" has the meaning		
20	assigned by Section 324.055.		
21	(7) "Military service member" means:		
22	(A) a member of the armed forces of the United		
23	States;		
24	(B) a member of the Texas National Guard or the		
25	National Guard of another state serving on active duty under an		
26	order of the president of the United States;		
27	(C) a member of a reserve component of the armed

- 5 (8) "Service provider" means a cable service provider,
- 6 <u>a health spa services provider</u>, an Internet service provider, a

- 8 (9) "State active duty" and "Texas military forces"
- 9 have the meanings assigned by Section 437.001, Government Code.
- 10 (10) "Telecommunications provider" has the meaning
- 11 assigned by Section 51.002, Utilities Code.
- 12 Sec. 606.002. SUSPENSION OR TERMINATION OF CERTAIN SERVICES
- 13 FOR ACTIVE DUTY MILITARY SERVICE MEMBERS. (a) This section
- 14 applies only to the following services:
- (1) cable service;
- 16 (2) health spa services;
- 17 (3) services providing connectivity to the Internet or
- 18 another wide area network;
- 19 (4) telecommunications services; and
- 20 (5) video service.
- 21 (b) Except as provided by Subsection (i), a military service

- 17 (2) the next business day after the date the service
- 18 provider receives a written notice of suspension or termination
- 19 under this section, if the notice is received on the weekend or a
- 20 holiday.
- 21 <u>(e) The suspension or termination of the service is</u>
- 22 effective on the applicable suspension or termination date
- 23 prescribed by Subsection (d). Except as provided by Subsection
- 24 (f), a military service member is not liable for the payment of any
- 25 <u>service suspended or terminated under this section after the</u>
- 26 effective date of the suspension or termination unless and until
- 27 the service member reinstates the service as provided by Section

- 2 (f) If a service provider does not receive the proof of the
- 3 official orders as required by Subsection (c), the service provider
- 4 may reinstate the suspended or terminated service. The military
- 5 service member who requested the suspension or termination is
- 6 liable for the payment of that service from the original effective
- 7 date of the suspension or termination until the date the service
- 8 member provides the required proof to the service provider. The
- 9 effective date of a suspension or termination of a reinstated
- 10 service as provided by this subsection becomes the date on which the
- 11 service provider receives the required proof.
- 12 (g) Except as provided by this section, a service provider
- 13 may not charge a penalty, fee, loss of deposit, or any other
- 14 additional cost due to a suspension or termination of a service
- 15 <u>under this section.</u>
- 16 (h) A military service member may reinstate a service that
- 17 is suspended or terminated under this section in the manner
- 18 provided by Section 606.003.
- 19 (i) A military service member may terminate a contract for
- 20 cellular telephone service or telephone exchange service in the
- 21 manner provided by 50 U.S.C. Section 3956, if applicable.
- Sec. 606.003. REINSTATEMENT OF CERTAIN SERVICES FOR ACTIVE
- 23 DUTY MILITARY SERVICE MEMBERS. (a) A military service member who
- 24 suspends or terminates a service under Section 606.002 and whose
- 25 period of active duty military service has ended may reinstate the
- 26 service by providing:
- 27 (1) a written notice of reinstatement to the service

- 1 provider of the suspended or terminated service; and
- 2 (2) a document evidencing proof of the date the active
- 3 duty military service ends not later than the 90th day after the
- 4 date on which the service member's active duty military service
- 5 ended.
- 6 (b) A service provider that receives a written notice of
- 7 reinstatement of a service and the documentation required by

- 17 (c) A service provider shall reinstate a service as provided
- 18 by Subsection (b) within a reasonable time, but not later than the

- 20 notice of reinstatement.
- 21 <u>(d) A service provider may not charge a penalty, fee, loss</u>
- 22 of deposit, or other additional cost due to a reinstatement of
- 23 services under this section.
- SECTION 3. Chapter 606, Business & Commerce Code, as added
- 25 by this Act, applies only to a contract for services entered into or
- 26 renewed on or after the effective date of this Act.
- 27 SECTION 4. The change in law made by this Act applies only
