- 5 SECTION 1. Section 18.005(c), Education Code, is amended to
- 6 read as follows:

- 7 (c) A Job Corps diploma program shall:
- 8 (1) develop educational programs specifically
- 9 designed for persons eligible for enrollment in a Job Corps
- 10 training program established by the United States Department of
- 11 Labor;

- 16 provide programs and services under contract with the United States

- 18 (3) provide a course of instruction that includes the
- 19 required curriculum under Subchapter A, Chapter 28;
- 20 (4) require that students enrolled in the diploma
- 21 program satisfy the requirements of <u>Sections 18.0055 and</u> [<del>Section</del>]
- 22 39.025 before receiving a diploma under this chapter; and
- 23 (5) comply with a requirement imposed under this title
- 24 or a rule adopted under this title relating to the Public Education

- 1 Information Management System (PEIMS) to the extent necessary to
- 2 determine compliance with this chapter, as determined by the
- 3 commissioner.
- 4 SECTION 2. Chapter 18, Education Code, is amended by adding
- 5 Section 18.0055 to read as follows:
- 6 Sec. 18.0055. LOCAL ASSESSMENT REQUIRED: WRITING. A Job
- 7 Corps diploma program shall provide for the evaluation of student
- 8 achievement in writing consistent with the requirements provided
- 9 for school districts under Section 39.0264 for courses listed under
- 10 Section 39.0264(b). A Job Corps diploma program shall provide for
- 11 notice and reporting of performance of students assessed consistent
- 12 with the requirements under Section 39.0264.
- SECTION 3. Section 25.005(b), Education Code, is amended to
- 14 read as follows:
- 15 (b) A reciprocity agreement must:
- 16 (1) address procedures for:
- 17 (A) transferring student records;
- 18 (B) awarding credit for completed course work;
- 19 and
- 20 (C) permitting a student to satisfy the
- 21 requirements of:
- 22 (i) Section 39.025 through successful
- 23 performance on comparable end-of-course or other exit-level
- 24 assessment instruments administered in another state; and
- 25 (ii) Section 39.0264(b) through successful
- 26 performance under a method of assessment in another state
- 27 determined by the school district in which the student attends to be

- 1 comparable to or at least as rigorous as the method of assessment
- 2 used by that district; and
- 3 (2) include appropriate criteria developed by the
- 4 agency.
- 5 SECTION 4. Sections 28.025(b-4), (b-7), (c), and (d),
- 6 Education Code, are amended to read as follows:
- 7 (b-4) A school district may offer the curriculum described
- 8 in Subsections (b-1)(1) through (4) in an applied manner. Courses
- 9 delivered in an applied manner must cover the essential knowledge
- 10 and skills, and the student shall be $\underline{:}$
- 11 (1) administered the applicable end-of-course
- 12 assessment instrument as provided by Sections 39.023(c) and 39.025;
- 13 and
- 14 (2) for an applicable course described by Subsection
- (b-1)(1), assessed as provided by Section 39.0264(b).
- 16 (b-7) The State Board of Education, in coordination with the
- 17 Texas Higher Education Coordinating Board, shall adopt rules to
- 18 ensure that a student may comply with the curriculum requirements
- 19 under the foundation high school program or for an endorsement
- 20 under Subsection (c-1) by successfully completing appropriate
- 21 courses in the core curriculum of an institution of higher
- 22 education under Section 61.822. Notwithstanding Subsection (b-15)
- 23 or (c) of this section, Section 39.025 or 39.0264(b), or any other
- 24 provision of this code and notwithstanding any school district
- 25 policy, a student who has completed the core curriculum of an

- 11 (c) A person may receive a diploma if the person is eligible
- 12 for a diploma under Section 28.0251. In other cases, a student may
- 13 graduate and receive a diploma only if:
- 14 (1) the student successfully completes the curriculum
- 15 requirements identified by the State Board of Education under
- 16 Subsection (a) and complies with <u>Sections</u> [Section] 39.025 and
- 17 39.0264(b); or
- 18 (2) the student successfully completes an
- 19 individualized education program developed under Section 29.005.
- 20 (d) A school district may issue a certificate of coursework
- 21 completion to a student who successfully completes the curriculum
- 22 requirements identified by the State Board of Education under
- 23 Subsection (a) but who fails to comply with Section 39.025 or
- 24 39.0264(b). A school district may allow a student who receives a
- 25 certificate to participate in a graduation ceremony with students

- 27 SECTION 5. Section 28.0255(g), Education Code, is amended

- 2 (g) A student is entitled to a high school diploma if the

- 6 (2) performs satisfactorily, as determined by the
- 7 commissioner under Subsection (h), on end-of-course assessment
- 8 instruments listed under Section 39.023(c) for courses in which the
- 9 student was enrolled; and
- 10 (3) demonstrates performance that indicates that the
- 11 student has successfully achieved the essential knowledge and
- 12 skills in writing, as determined by standards established by the
- 13 board of trustees of the school district, for each course listed
- 14 under Section 39.0264(b) in which the student is enrolled.
- SECTION 6. Section 29.087(f), Education Code, is amended to
- 16 read as follows:
- 17 (f) A student participating in a program authorized by this
- 18 section, other than a student ordered to participate under
- 19 Subsection (d)(1), must have taken the appropriate end-of-course
- 20 assessment instruments specified by Section 39.023(c) and been
- 21 assessed for the appropriate courses as provided by Section
- 22 <u>39.0264(b)</u> before entering the program and must take each
- 23 appropriate end-of-course assessment instrument administered
- 24 during the period in which the student is enrolled in the program
- 25 and be assessed for each appropriate course as provided by Section
- 39.0264(b) during the period in which the student is enrolled in the
- 27 program. Except for a student ordered to participate under

- 1 Subsection (d)(1), a student participating in the program may not
- 2 take the high school equivalency examination unless the student has
- 3 taken the assessment instruments required by this subsection and

- 6 SECTION 7. Section 29.402(b), Education Code, is amended to
- 7 read as follows:
- 8 (b) A person who is under 26 years of age is eligible to
- 9 enroll in a dropout recovery program under this subchapter if the

- 11 (1) must complete not more than three course credits
- 12 to complete the curriculum requirements for the foundation high
- 13 school program for high school graduation; or
- 14 (2) has failed to:
- 15 <u>(A)</u> perform satisfactorily on an end-of-course
- 16 assessment instrument administered under Section 39.023(c) or an
- 17 assessment instrument administered under Section 39.023(c) as that
- 18 section existed before amendment by Chapter 1312 (S.B. 1031), Acts
- 19 of the 80th Legislature, Regular Session, 2007; or
- 20 (B) demonstrate satisfactory performance under
- 21 an assessment required by Section 39.0264(b).
- SECTION 8. Section 30.021(e), Education Code, is amended to
- 23 read as follows:
- (e) The school shall cooperate with public and private
- 25 agencies and organizations serving students and other persons with
- 26 visual impairments in the planning, development, and
- 27 implementation of effective educational and rehabilitative service

- 1 delivery systems associated with educating students with visual
- 2 impairments. To maximize and make efficient use of state
- 3 facilities, funding, and resources, the services provided in this
- 4 area may include conducting a cooperative program with other
- 5 agencies to serve students who have graduated from high school by

- 7 regular education, excluding satisfactory performance under
- 8 Sections [Section] 39.025 and 39.0264(b), who are younger than 22
- 9 years of age on September 1 of the school year and who have

- SECTION 9. Sections 30.104(b) and (c), Education Code, are

- 17 program if:
- 18 (1) the student successfully completes the curriculum
- 19 requirements identified by the State Board of Education under
- 20 Section 28.025(a) and complies with:
- 21 <u>(A)</u> Section 39.025; and
- 22 (B) Section 39.0264(b), including by
- 23 demonstrating satisfactory performance under the method of

- 12 amending Subsection (d) and adding Subsection (d-1) to read as

- 14 (d) A juvenile justice alternative education program must
- 15 focus on English language arts, mathematics, science, social
- 16 studies, and self-discipline. Each school district shall consider
- 17 course credit earned by a student while in a juvenile justice
- 18 alternative education program as credit earned in a district
- 19 school. Each program shall administer assessment instruments under

- 21 grades and courses as provided by Subsection (d-1), and shall offer

- 7 criterion-referenced assessment instruments designed to assess
- 8 essential knowledge and skills in reading, English language arts
- 9 [writing], mathematics, social studies, and science. Except as
- 10 provided by Subsection (a-2), all students, other than students

- 12 39.027, shall be assessed in:
- 13 (1) mathematics, in grades three and five without the
- 14 aid of technology and in grade eight with the aid of technology on

- 4 instruments for secondary-level courses in Algebra I, biology,
- 5 English I, English II, and United States history. The Algebra I
- 6 end-of-course assessment instrument must be administered with the
- 7 aid of technology. The English I and English II end-of-course
- 8 assessment instruments must each assess essential knowledge and
- 9 skills in both reading and language arts [writing] in the same
- 10 assessment instrument and must provide a single score. A school
- 11 district shall comply with State Board of Education rules regarding

- 27 evaluate student achievement in writing, each school district shall

- 1 assess students in grades four and seven and at the end of English I
- 2 and English II secondary-level courses in accordance with the
- 3 essential knowledge and skills for writing. A district may use any
- 4 method the district determines appropriate for assessing students
- 5 under this section, including portfolio assessment.
- 6 (b) A student assessed at the end of an English I or English
- 7 II secondary-level course is required to demonstrate performance
- 8 that indicates the student has successfully achieved the essential
- 9 knowledge and skills in writing for the course as determined by
- 10 standards established by the board of trustees of the school
- 11 district the student attends. A student may not receive a high
- 12 school diploma until the student has demonstrated satisfactory
- 13 performance in the manner provided by this subsection.
- 14 (c) The school district a student attends shall provide
- 15 written notice of the performance of a student assessed as required
- 16 under this section to the student's parent or person standing in
- 17 parental relation to the student.
- (d) Each school year, each school district shall prepare a

- 7 SECTION 17. Section 39.034(d), Education Code, is amended
- 8 to read as follows:
- 9 (d) The agency shall determine the necessary annual
- 10 improvement required each year for a student to be prepared to
- 11 perform satisfactorily on, as applicable:
- 12 (1) the grade five assessment instruments;
- 13 (2) the grade eight assessment instruments; and
- 14 (3) the end-of-course assessment instruments required
- 15 under <u>Section 39.023</u> [this subchapter for graduation].
- SECTION 18. Not later than September 1, 2018, the Texas
- 17 Education Agency shall adopt or develop appropriate
- 18 criterion-referenced assessment instruments designed to assess
- 19 essential knowledge and skills in English language arts as required
- 20 by Section 39.023, Education Code, as amended by this Act.
- 21 SECTION 19. This Act applies beginning with the 2017-2018
- 22 school year.
- 23 SECTION 20. This Act takes effect immediately if it
- 24 receives a vote of two-thirds of all the members elected to each
- 25 house, as provided by Section 39, Article III, Texas Constitution.
- 26 If this Act does not receive the vote necessary for immediate
- 27 effect, this Act takes effect September 1, 2017.
