## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the campus sexual assault policy at a public
3	institution of higher education.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 51.9363, Education Code, is amended by
6	amending Subsection (e) and adding Subsections (f), (g), and (h) to
7	read as follows:
8	(e) Each institution of higher education shall provide to
9	students enrolled at the institution information regarding the
10	protocol for reporting incidents of campus sexual assault adopted
11	under Subsection (b), including the name, office location, and
12	contact information of the institution's Title IX coordinator, by:
13	(1) e-mailing the information to each student at the
14	beginning of each semester or other academic term; and
15	(2) including the information in the orientation
16	required under Subsection (d).
17	(f) As part of the protocol for responding to reports of

- campus sexual assault adopted under Subsection (b), each 18
- 19 institution of higher education shall:
- (1) ensure that each alleged victim or alleged 20
- 21 perpetrator of an incident of campus sexual assault and any other
- person who reports such an incident is offered counseling provided 22
- by a counselor who does not provide counseling to any other person 23
- 24 involved in the incident; and

- 1 (2) notwithstanding any other law, allow an alleged
- 2 victim or alleged perpetrator of an incident of campus sexual
- 3 assault to drop a course in which both parties are enrolled without
- 4 any academic penalty.
- 5 (g) An institution of higher education may not take any
- 6 disciplinary action against a student enrolled at the institution
- 7 who reports to the institution being the victim of, or a witness to,
- 8 an incident of campus sexual assault for a violation by the student
- 9 of the institution's policies on student conduct that involves
- 10 alcohol or drug use and occurs in relation to the incident. This
- 11 subsection may not be construed to limit an institution's ability
- 12 to provide amnesty from application of the institution's policies
- 13 in circumstances not described by this subsection.
- 14 (h) Each biennium, each institution of higher education
- 15 shall review the institution's campus sexual assault policy and,
- 16 with approval of the institution's governing board, revise the
- 17 policy as necessary.
- SECTION 2. Section 51.9363, Education Code, as amended by
- 19 this Act, applies beginning with the 2017-2018 academic year.
- 20 SECTION 3. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2017.
