- (C) 24 brokerage of same-day or expedited courier

- 1 and logistics services to be completed by a person or entity under a

- 4 (2) during the period on which margin is based, is
- 5 registered as a motor carrier under Chapter 643, Transportation
- 6 Code, and if the taxable entity operates on an interstate basis, is
- 7 registered as a motor carrier or broker under the motor vehicle
- 8 registration system established under 49 U.S.C. Section 14504a or a
- 9 similar federal registration program that replaces that system

- 12 (3) maintains an automobile liability insurance

- 25 storage company, or overnight delivery service; and
- 26 (8) is not delivering items that the taxable entity or
- 27 an affiliated entity sold.

SECTION 18. (a) 3 The changes in law made by this Act apply only to an offense or violation committed on or after the effective 4 date of this Act. An offense or violation committed before the 5 6 effective date of this Act is governed by the law in effect on the 7 date the offense or violation was committed, and the former law is 8 continued in effect for that purpose. For purposes of this section, an offense or violation was committed before the effective date of this Act if any element of the offense or violation occurred before 10 that date. 11

12 (b) The change in law made by this Act relating to an application filed under Chapter 643, Transportation Code, applies only to an application filed under that chapter on or after the effective date of this Act. An application filed before that date is governed by the law in effect on the date the application was filed, and the former law is continued in effect for that purpose.

18 SECTION 19. This Act takes effect January 1, 2018.
