- 3 SECTION 3. Chapter 34 (S.B. 115), Acts of the 41st
- 4 Legislature, 1st Called Session, 1929, is repealed.
- 5 SECTION 4. This Act takes effect immediately if it receives

- 7 provided by Section 39, Article III, Texas Constitution. If this
- 8 Act does not receive the vote necessary for immediate effect, this
- 9 Act takes effect September 1, 2017.
