- 2 relating to the evaluation of and improvements to the quality of the
- 3 Texas Workforce Commission's subsidized child care program.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 302.0042, Labor Code, is amended by
- 6 amending Subsection (b) and adding Subsection (c) to read as
- 7 follows:
- 8 (b) The commission's evaluation must assess:
- 9 (1) the use of current federal child care funds by each
- 10 local workforce development board;
- 11 (2) the ability of each local workforce development
- 12 board to meet child care performance measures;
- 13 (3) the <u>estimated</u> [average] cost <u>incurred</u> by child
- 14 care providers [of child care] in each local workforce development
- 15 area as stated in the report required under 45 C.F.R. Section
- 16 98.45(f)(1);
- 17 (4) the average price charged by child care providers
- 18 for child care in each local workforce development area as stated in
- 19 the market rate survey conducted under 45 C.F.R. Section 98.45(c);
- 20 <u>(5)</u> the poverty rate of each local workforce
- 21 development area compared to the state's poverty rate;
- (6) $\left[\frac{(5)}{(5)}\right]$ the number of children on waiting lists for
- 23 child care in each local workforce development area; [and]
- (7) $[\frac{(6)}{(6)}]$ the number of places that are reserved for

- 1 participants in the child care subsidy program out of the total
- 2 number of children enrolled with a provider on a full-time basis
- 3 categorized by age of the child for each provider [vacant slots
- 4 available for child care placement] in each local workforce
- 5 development area that is certified as a 2-star, 3-star, or 4-star
- 6 provider in the Texas Rising Star Program or that does not
- 7 participate in the Texas Rising Star Program;
- 8 (8) the total number of child care providers
- 9 participating in the Texas Rising Star Program in each local
- 10 workforce development area and the number of 2-star, 3-star, and
- 11 4-star rated child care providers in the local workforce
- 12 development area;
- 13 (9) the number of child care providers participating
- 14 in the Texas Rising Star Program in each local workforce
- 15 <u>development area as a percentage of the total number of subsidized</u>
- 16 child care providers in the local workforce development area and
- 17 the number of 2-star, 3-star, and 4-star rated child care providers
- 18 <u>in the local workforce development area as a percentage of the total</u>
- 19 number of subsidized child care providers in the local workforce
- 20 <u>deve</u>lopment area;
- 21 (10) the total number of children enrolled in
- 22 <u>subsidized child care providers participating in the Texas Rising</u>
- 23 Star Program in each local workforce development area and the
- 24 number of subsidized children enrolled in 2-star, 3-star, and
- 25 4-star rated child care providers in the local workforce
- 26 development area; and
- 27 (11) the number of subsidized children enrolled in

- 1 child care providers participating in the Texas Rising Star Program
- 2 in each local workforce development area as a percentage of the
- 3 total number of subsidized children enrolled in child care
- 4 providers in the local workforce development area and the number of
- 5 subsidized children enrolled in 2-star, 3-star, and 4-star rated
- 6 child care providers in the local workforce development area as a
- 7 percentage of the total number of subsidized children enrolled in
- 8 child care providers in the local workforce development area.
- 9 (c) For the purposes of evaluation under this section, the
- 10 commission shall annually update the information described by
- 11 Subsections (b)(6)-(11).
- 12 SECTION 2. Section 302.0043, Labor Code, is amended by
- 13 adding Subsection (c-1) and amending Subsections (e) and (f) to
- 14 read as follows:
- 15 <u>(c-1)</u> The commission shall measure and evaluate the
- 16 progress of the commission's child care program regarding:
- 17 (1) coordination by the commission with the Texas
- 18 Education Agency to assign a Public Education Information
- 19 Management System (PEIMS) number to children younger than six years
- 20 of age enrolled in the commission's child care program;
- 21 (2) coordination with the Texas Education Agency,
- 22 school districts, and open-enrollment charter schools on any
- 23 prekindergarten quality improvement efforts;
- 24 (3) efforts to increase coordination between
- 25 participating providers in the commission's child care program,
- 26 school districts, and open-enrollment charter schools;
- 27 (4) facilitation of child care provider enrollment in

- 1 the Texas Rising Star Program and progression of providers to the
- 2 highest rating level in the program; and
- 3 (5) development and implementation of rates and
- 4 payments, as determined by local workforce development boards, to:
- 5 (A) allow participating providers to provide
- 6 high quality child care; and
- 7 (B) ensure that the commission meets performance
- 8 measures established by the legislature for the average number of
- 9 children served by the commission's child care program per day.
- 10 (e) The commission shall make the information collected by
- 11 the commission and the commission's findings available to local
- 12 workforce development boards, school districts, open-enrollment
- 13 charter schools, and the public.
- 14 (f) Not later than January 15 of each odd-numbered year, the
- 15 commission shall report to the legislature regarding the
- 16 commission's findings regarding the effectiveness of the
- 17 commission's child care program. The report must:
- 18 (1) include employment outcome information,
- 19 disaggregated by local workforce development area, regarding
- 20 parents receiving subsidized care under the program; [and]
- 21 (2) identify multiyear trends in the information
- 22 collected and analyzed by the commission under this section,
- 23 including trends in the information for at least the five state
- 24 fiscal years preceding the date of the report; and
- 25 (3) include information described by Sections
- 26 302.0042(b)(8)-(11).
- SECTION 3. Section 302.00435, Labor Code, is amended to

- 1 read as follows:
- 2 Sec. 302.00435. SUBSIDIZED CHILD CARE PROGRAM; INPUT
- 3 POLICY. (a) The commission shall develop a policy for obtaining,
- 4 through appropriate methods, input from interested parties
- 5 regarding its subsidized child care program and for using that
- 6 input in administering that program.
- 7 (b) The policy developed under Subsection (a) must include
- 8 methods for obtaining input from the Texas Education Agency, school
- 9 districts, open-enrollment charter schools, subsidized child care
- 10 providers, relevant businesses, and the public, regarding:
- 11 (1) improving coordination between the subsidized
- 12 child care program and prekindergarten programs; and
- (2) increasing the quality of and access to the
- 14 subsidized child care program.
- 15 SECTION 4. This Act takes effect September 1, 2017.
