- 6 SECTION 1. Section 490G.001, Government Code, is amended by
- 7 amending Subdivision (2-a) and adding Subdivision (2-b) to read as

- 9 (2-a) "Office" means the Texas Economic Development

- 11 (2-b) "Rural county" means a county with a population of
- 12 less than 60,000.
- 13 SECTION 2. Chapter 490G, Government Code, is amended by
- 14 adding Section 490G.0055 to read as follows:
- 15 Sec. 490G.0055. REVIEW OF PROGRAM ESTABLISHED BY TEXAS
- 16 ECONOMIC DEVELOPMENT ACT; PERFORMANCE MATRIX. (a) The board shall
- 17 examine the effectiveness, efficiency, and financial impact on this

- 7 standing committee of the senate and house of representatives with
- 8 primary jurisdiction over economic development a report containing
- 9 findings and recommendations resulting from each review of state
- 10 incentive programs and funds <u>and of the ad valorem tax incentive</u>
- 11 program established by Chapter 313, Tax Code, conducted by the
- 12 board under this chapter during the preceding two calendar years.
