- 3 Board of projects undertaken by certain economic development

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 490G.001, Government Code, is amended by
- 7 amending Subdivisions (1) and (2-a) and adding Subdivisions (1-a),
- 8 (2-b), and (4) to read as follows:
- 9 (1) "Authorizing municipality" means the municipality
- 10 that authorizes the creation of a Type A or Type B corporation.
- 11 (1-a) "Board" means the Economic Incentive Oversight
- 12 Board.
- 13 (2-a) "Office" means the Texas Economic Development
- 14 and Tourism Office.
- 15 <u>(2-b)</u> "Rural county" means a county with a population
- 16 of less than 60,000.
- 17 (4) "Type A corporation" and "Type B corporation" have
- 18 the meanings assigned those terms by Section 501.002, Local
- 19 Government Code.
- SECTION 2. Chapter 490G, Government Code, is amended by
- 21 adding Section 490G.0055 to read as follows:
- Sec. 490G.0055. REVIEW OF ECONOMIC DEVELOPMENT CORPORATION
- 23 PROJECTS; PERFORMANCE MATRIX. (a) The board shall examine the
- 24 effectiveness, efficiency, and financial impact on this state of

- 1 projects undertaken by Type A and Type B corporations under
- 2 Subtitle C1, Title 12, Local Government Code.
- 3 (b) The board shall develop a performance matrix that
- 4 clearly establishes the economic performance indicators, measures,
- 5 <u>and metrics that will guide the board's evaluations of those</u>
- 6 projects.
- 7 (c) A Type A or Type B corporation shall provide to the board
- 8 on request any agreement relating to a project undertaken by the
- 9 corporation and any other information concerning the project as
- 10 necessary to enable the board to perform the board's duties under
- 11 this chapter.
- 12 SECTION 3. Chapter 490G, Government Code, is amended by
- 13 adding Section 490G.0065 to read as follows:
- 14 Sec. 490G.0065. SCHEDULE OF REVIEW OF ECONOMIC DEVELOPMENT
- 15 CORPORATION PROJECTS. (a) The board shall develop a schedule for
- 16 the periodic review of each project or category of projects
- 17 described by Section 490G.0055 and identified by the board for the
- 18 purposes of making recommendations concerning project
- 19 effectiveness and efficiency to the Texas Economic Development and
- 20 Tourism Office and reporting the findings and recommendations
- 21 resulting from the project review to the legislature as required by
- 22 Section 490G.007. The board shall review and make findings and
- 23 recommendations regarding each project or category of projects as
- 24 described by this section according to the review schedule.
- 25 (b) The board, on request, shall provide to the governing
- 26 body of a Type A corporation's or Type B corporation's authorizing
- 27 municipality any recommendations submitted to the office under

- 1 Subsection (a) concerning a project or category of projects
- 2 undertaken by the corporation created by the municipality.
- 3 SECTION 4. Section 490G.007, Government Code, is amended to
- 4 read as follows:
- 5 Sec. 490G.007. BIENNIAL REPORT. Not later than January 1 of
- 6 each odd-numbered year, the board shall submit to the lieutenant
- 7 governor, the speaker of the house of representatives, and each
- 8 standing committee of the senate and house of representatives with
- 9 primary jurisdiction over economic development a report containing
- 10 findings and recommendations resulting from each review of state
- 11 incentive programs and funds and of projects undertaken by Type A or
- 12 Type B corporations that is conducted by the board under this
- 13 chapter during the preceding two calendar years.
- 14 SECTION 5. This Act takes effect September 1, 2017.
