- 2 relating to specialty license plates to honor certain Purple Heart
- 3 recipients.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Section 372.053, Transportation
- 6 Code, is amended to read as follows:
- 7 Sec. 372.053. [VETERAN] DISCOUNT PROGRAM FOR CERTAIN
- 8 VETERANS AND PURPLE HEART RECIPIENTS.
- 9 SECTION 2. Section 372.053(a), Transportation Code, is
- 10 amended to read as follows:
- 11 (a) A toll project entity may establish a discount program
- 12 for electronic toll collection customers. The program must
- 13 include free or discounted use of the entity's toll project by an
- 14 electronic toll collection customer whose account relates to a
- 15 vehicle registered under Section 504.202, [or] 504.315(f) or (g),
- 16 or 504.5115.
- SECTION 3. Subchapter F, Chapter 504, Transportation Code,
- 18 is amended by adding Section 504.5115 to read as follows:
- 19 Sec. 504.5115. CERTAIN PURPLE HEART RECIPIENTS. (a) The
- 20 department shall issue specialty license plates for recipients of a
- 21 Purple Heart awarded by the Department of Public Safety or another
- 22 law enforcement agency in this state.
- 23 (b) The fee for issuance of one set of the license plates is
- 24 \$3.

- 1 (c) A person issued specialty license plates under this
- 2 section shall be issued one set of the license plates without
- 3 payment of the registration fee required under Chapter 502.
- 4 SECTION 4. The heading to Section 681.008, Transportation
- 5 Code, is amended to read as follows:
- 6 Sec. 681.008. PARKING PRIVILEGES: CERTAIN VETERANS AND
- 7 [MILITARY] AWARD RECIPIENTS.
- 8 SECTION 5. Section 681.008(b), Transportation Code, is
- 9 amended to read as follows:
- 10 (b) A vehicle on which license plates described by
- 11 Subsection (a)(2) or issued under Section 504.202, 504.308,
- 12 504.310, 504.315, 504.316, [or] 504.319, or 504.5115 are displayed
- 13 is exempt from the payment of a parking fee collected through a
- 14 parking meter charged by a governmental authority other than a
- 15 branch of the federal government, when being operated by or for the
- 16 transportation of:
- 17 (1) the person who registered the vehicle under
- 18 Section 504.202(a), 504.308, 504.310, 504.315, 504.316, [ex]
- 19 504.319, or 504.5115;
- 20 (2) a person described in Section 504.202(b) if the
- 21 vehicle is registered under that subsection; or
- 22 (3) the owner or operator of a vehicle displaying
- 23 license plates described by Subsection (a)(2).
- SECTION 6. This Act takes effect September 1, 2017.
