SECTION 2. Section 502.453(a), Transportation Code, 17 is 18 amended to read as follows: (a) The owner of a motor vehicle, trailer, or semitrailer 19 may annually apply for registration under Section 502.451 and is 20 exempt from the payment of a registration fee under this chapter if 21 the vehicle is: 22 23 (1) owned by and used exclusively in the service of: 24 (A) the United States;

1 (B) this state; [<del>or</del>] 2 (C) a county, municipality, or school district in 3 this state; or 4 (D) an open-enrollment charter school; 5 (2) owned by a commercial transportation company and used exclusively to provide public school transportation services 6 to a school district under Section 34.008, Education Code; 7 8 (3) designed and used exclusively for fire fighting; 9 (4) owned by a volunteer fire department and used 10 exclusively in the conduct of department business; 11 (5) privately owned and used by volunteer а exclusively in county marine law enforcement activities, including 12 rescue operations, under the direction of the sheriff's department; 13 14 (6) used by law enforcement under an alias for covert 15 criminal investigations; or 16 (7) owned by units of the United States Coast Guard 17 Auxiliary headquartered in Texas and used exclusively for conduct of United States Coast Guard or Coast Guard Auxiliary business and 18 19 operations, including search and rescue, emergency communications, and disaster operations. 20 21 SECTION 3. The changes in law made by this Act do not affect tax liability accruing before the effective date of this Act. That 22 23 liability continues in effect as if this Act had not been enacted, 24 and the former law is continued in effect for the collection of
