(a) 6 Except as otherwise provided by this section, the changes in law made by this Act apply beginning with 7 8 tuition and fees charged for the 2017 fall semester. Tuition and fees charged for a term or semester before the 2017 fall semester 9 are governed by the law in effect immediately before the effective 10 date of this Act, and the former law is continued in effect for that 11 12 purpose.

(b) Section 54.201, Education Code, as added by this Act, applies to a person's eligibility for an exemption or waiver from the payment of all or part of tuition or other fees beginning with tuition and fees charged for the 2018 fall semester.

SECTION 5. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2017.
