No. 3894 1 institution; or (B) with the intent to establish, maintain, or 2 3 participate in a combination or in the profits of a combination; 4 (6) the person: 5 (A) while incarcerated for an offense under this section or Section 19.02, murders another; or 6 7 while serving a sentence of life imprisonment (B) 8 or a term of 99 years for an offense under Section 20.04, 22.021, or 29.03, murders another; 9 10 (7)the person murders more than one person: 11 (A) during the same criminal transaction; or 12 (B) during different criminal transactions but 13 the murders are committed pursuant to the same scheme or course of 14 conduct; 15 (8) the person murders an individual under $\underline{15}$ [$\underline{10}$] 16 years of age; or 17 (9) the person murders another person in retaliation for or on account of the service or status of the other person as a 18 19 judge or justice of the supreme court, the court of criminal 20 appeals, a court of appeals, a district court, a criminal district court, a constitutional county court, a statutory county court, a 21 22 justice court, or a municipal court. 23 SECTION 3. The change in law made by this Act applies only

to an offense committed on or after the effective date of this Act. An offense committed before the effective date of this Act is governed by the law in effect on the date the offense was committed, and the former law is continued in effect for that purpose. For

1 purposes of this section, an offense was committed before the 2 effective date of this Act if any element of the offense occurred 3 before that date.
