A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the automatic admission to general academic teaching
- 3 institutions and eligibility for certain scholarships of a student
- 4 who is the valedictorian of the student's high school graduating
- 5 class.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 51.803, Education Code, is amended by
- 8 adding Subsection (d-1) and amending Subsection (h) to read as
- 9 follows:
- 10 (d-1) In addition to admissions required under Subsection
- 11 (a), each general academic teaching institution shall admit an
- 12 applicant for admission to the institution as an undergraduate if
- 13 the applicant graduated as the valedictorian of the student's high
- 14 school graduating class in one of the two school years preceding the
- 15 academic year for which the student is applying for admission and
- 16 satisfies the requirements of Subsections (a)(1) through (3).
- 17 Subsections (b) and (c) apply to an applicant for admission under
- 18 this subsection.
- 19 (h) An institution that admits under this section an
- 20 applicant qualified for automatic admission under Subsection (a) or
- 21 (d-1) may admit the applicant for either the fall semester of the
- 22 academic year for which the applicant applies or for the summer
- 23 session preceding that fall semester, as determined by the
- 24 institution.

- 1 SECTION 2. Section 56.484, Education Code, is amended to
- 2 read as follows:
- 3 Sec. 56.484. INITIAL ELIGIBILITY FOR SCHOLARSHIP. To be
- 4 eligible for a scholarship under this subchapter, a student must:
- 5 (1) have graduated from a public or accredited private
- 6 high school in this state while ranked in the top 10 percent or as
- 7 the valedictorian of the student's graduating class, subject to
- 8 Section 56.487(b);
- 9 (2) have completed the recommended or advanced high
- 10 school curriculum established under Section 28.025 or its
- 11 equivalent;
- 12 (3) have applied for admission as a first-time
- 13 freshman student for the 2010-2011 academic year or a subsequent
- 14 academic year to an institution of higher education that has
- 15 elected to offer admissions for that academic year to applicants as
- 16 provided by Section 51.803(a-1);
- 17 (4) enroll as a first-time freshman student in an
- 18 institution of higher education not later than the 16th month after
- 19 the date of the student's high school graduation;
- 20 (5) have been awarded a TEXAS grant under Subchapter M
- 21 for the same semester or other academic term for which the
- 22 scholarship will be awarded;
- 23 (6) be a Texas resident under Section 54.052; and
- 24 (7) comply with any other eligibility requirements
- 25 established by coordinating board rule.
- SECTION 3. Section 51.803(d-1), Education Code, as added by
- 27 this Act, applies beginning with admissions to a general academic

- 1 teaching institution for the 2017-2018 academic year. Admissions
- 2 to a general academic teaching institution for an academic year
- 3 before that academic year are governed by the law in effect
- 4 immediately before the effective date of this Act, and the former
- 5 law is continued in effect for that purpose.
- 6 SECTION 4. The change in law made by this Act to Section
- 7 56.484, Education Code, applies beginning with scholarships
- 8 awarded for the 2017-2018 academic year. Scholarships awarded for
- 9 an academic year before that academic year are governed by the law
- 10 in effect immediately before the effective date of this Act, and the
- 11 former law is continued in effect for that purpose.
- 12 SECTION 5. This Act takes effect immediately if it receives
- 13 a vote of two-thirds of all the members elected to each house, as
- 14 provided by Section 39, Article III, Texas Constitution. If this
- 15 Act does not receive the vote necessary for immediate effect, this
- 16 Act takes effect September 1, 2017.
