(a) This section applies 8 9 only to a county with a population of more than 800,000 that is adjacent to an international border. 10 11 (b) A commissioners court by order may implement a process: 12 (1) applicable to a subdivision in which 50 percent or more of the lots are undeveloped or unoccupied on or after the 25th 13 14 anniversary of the date the plat for the subdivision was recorded with the county; and 15

- 16 (2) through which the county, to the extent practicable, may apply to the subdivision more current street, 17 road, drainage, and other infrastructure requirements. 18
- 19 (c) A regulation or standard adopted by a county under this section must be no less stringent than the minimum standards and 20 other requirements under the model rules for safe and sanitary 21 water supply and sewer services adopted under Section 16.343, Water 22 23 Code, and any other minimum public safety standards that would

otherwise be applicable to the subdivision.

- (d) A regulation or standard adopted by a county under this 1 section applies only to a lot that is owned by an individual, firm, 2 corporation, or other legal entity that directly or indirectly 3 offers lots for sale or lease as part of a common promotional plan 4 in the ordinary course of business, and each regulation or standard 5 must expressly state that limitation. For the purposes of this 6 subsection, "common promotional plan" means a plan or scheme of 7 operation undertaken by a person or a group acting in concert, 8 either personally or through an agent, to offer for sale or lease 9 more than two lots when the land is: 10
- 11 (1) contiguous or part of the same area of land; or
- 12 (2) known, designated, or advertised as a common unit 13 or by a common name.
- SECTION 2. The county may not apply an order adopted under Section 232.045, Local Government Code, as added by this Act, to a subdivision that is the subject of a judicial proceeding pending on May 1, 2017, to determine whether the subdivision is subject to a valid and existing subdivision plat.
- 19 SECTION 3. This Act takes effect January 1, 2018.
