H.B. No. 3930

A BILL TO BE ENTITLED

AN ACT

relating to health benefit plan coverage for early childhood intervention services.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. The heading to Subchapter E, Chapter 1367, Insurance Code, is amended to read as follows:

SUBCHAPTER E. EARLY CHILDHOOD INTERVENTION SERVICES AND DEVELOPMENTAL DELAYS

SECTION 2. Section 1367.201, Insurance Code, is amended to read as follows:

Sec. 1367.201. DEFINITION. In this subchapter, rehabilitative and habilitative therapies include:

- (1) occupational therapy evaluations and services;
- (2) physical therapy evaluations and services;
- (3) speech therapy evaluations and services; ~~and~~
- (4) dietary or nutritional evaluations;
- (5) specialized skills training by a person certified as an early intervention specialist;
- (6) applied behavior analysis treatment by a board certified behavior analyst or licensed psychologist; and
- (7) case management provided by a person certified as an early intervention specialist.

SECTION 3. Section 1367.202, Insurance Code, is amended to read as follows:

1           Sec. 1367.202. APPLICABILITY OF SUBCHAPTER. (a) This  
2 subchapter applies only to a health benefit plan that:

3           (1) provides benefits for medical or surgical expenses  
4 incurred as a result of a health condition, accident, or sickness,  
5 including an individual, group, blanket, or franchise insurance  
6 policy or insurance agreement, a group hospital service contract,  
7 or an individual or group evidence of coverage that is offered by:

8                   (A) an insurance company;

9                   (B) a group hospital service corporation  
10 operating under Chapter 842;

11                   (C) a fraternal benefit society operating under  
12 Chapter 885;

13                   (D) a stipulated premium company operating under  
14 Chapter 884;

15                   (E) a health maintenance organization operating  
16 under Chapter 843; or

17                   (F) a multiple employer welfare arrangement  
18 subject to regulation under Chapter 846;

19           (2) is offered by an approved nonprofit health  
20 corporation that holds a certificate of authority under Chapter  
21 844; or

22           (3) provides health and accident coverage through a  
23 risk pool created under Chapter 172, Local Government Code,  
24 notwithstanding Section 172.014, Local Government Code, or any  
25 other law.

26           (b) Notwithstanding any other law, this subchapter also  
27 applies to a standard health benefit plan provided under Chapter

1 1507.

2 (c) Notwithstanding any provision in Chapter 1575 or 1579 or  
3 any other law, this subchapter applies to:

4 (1) a basic plan under Chapter 1575; and

5 (2) a primary care coverage plan under Chapter 1579.

6 SECTION 4. Section 1367.203, Insurance Code, is amended to  
7 read as follows:

8 Sec. 1367.203. EXCEPTION. (a) This subchapter does not  
9 apply to:

10 (1) a plan that provides coverage:

11 (A) only for a specified disease or for another  
12 limited benefit;

13 (B) only for accidental death or dismemberment;

14 (C) for wages or payments in lieu of wages for a  
15 period during which an employee is absent from work because of  
16 sickness or injury;

17 (D) as a supplement to a liability insurance  
18 policy;

19 (E) for credit insurance;

20 (F) only for dental or vision care; or

21 (G) only for indemnity for hospital confinement;

22 (2) a small employer health benefit plan written under  
23 Chapter 1501;

24 (3) a Medicare supplemental policy as defined by  
25 Section 1882(g)(1), Social Security Act (42 U.S.C. Section 1395ss);

26 (4) a workers' compensation insurance policy;

27 (5) medical payment insurance coverage provided under

1 a motor vehicle insurance policy; or

2 (6) a long-term care insurance policy, including a  
3 nursing home fixed indemnity policy, unless the commissioner  
4 determines that the policy provides benefit coverage so  
5 comprehensive that the policy is a health benefit plan as described  
6 by Section 1367.202.

7 (b) This subchapter does not apply to a qualified health  
8 plan to the extent that a determination is made under 45 C.F.R.  
9 Section 155.170 that:

10 (1) this subchapter requires the plan to offer  
11 benefits in addition to the essential health benefits required  
12 under 42 U.S.C. Section 18022(b); and

13 (2) this state is required to defray the cost of the  
14 benefits mandated under this subchapter.

15 SECTION 5. Section 1367.204(a), Insurance Code, is amended  
16 to read as follows:

17 (a) A health benefit plan issuer must provide [~~offer~~]  
18 coverage that complies with this subchapter.

19 SECTION 6. Section 1367.205, Insurance Code, is amended by  
20 amending Subsections (a) and (b) and adding Subsections (d), (e),  
21 and (f) to read as follows:

22 (a) Except as provided by Subsection (d), a [A] health  
23 benefit plan that provides coverage for rehabilitative and  
24 habilitative therapies under this subchapter may not prohibit or  
25 restrict payment for covered services provided to a child and  
26 determined to be necessary to and provided in accordance with an  
27 individualized family service plan issued by the Interagency

1 Council on Early Childhood Intervention under Chapter 73, Human  
2 Resources Code.

3 (b) Except as provided by Subsection (d),  
4 rehabilitative [~~Rehabilitative~~] and habilitative therapies  
5 described by Subsection (a) must be covered in the amount,  
6 duration, scope, and service setting established in the child's  
7 individualized family service plan.

8 (d) Coverage required by this section for specialized  
9 skills training may be subject to an annual limit of \$7,000,  
10 including case management costs, for each child.

11 (e) A health benefit plan prior authorization requirement,  
12 or another requirement that a service be authorized, otherwise  
13 applicable to a covered rehabilitative or habilitative therapy  
14 service is satisfied if the service is specified in a child's  
15 individualized family service plan.

16 (f) In accordance with Part C, Individuals with  
17 Disabilities Education Act (IDEA) (20 U.S.C. Section 1431 et seq.),  
18 a child must exhaust available coverage under this section before  
19 the child may receive benefits provided by this state for early  
20 childhood intervention services. This section does not reduce the  
21 obligation of this state or the federal government under Part C,  
22 Individuals with Disabilities Education Act (IDEA) (20 U.S.C.  
23 Section 1431 et seq.).

24 SECTION 7. Section 1367.206, Insurance Code, is amended to  
25 read as follows:

26 Sec. 1367.206. PROHIBITED ACTIONS. Under the coverage  
27 required to be offered under this subchapter, a health benefit plan

1 issuer may not:

2 (1) except as provided by Section 1367.205(d), apply  
3 the cost of rehabilitative and habilitative therapies described by  
4 Section 1367.205(a) to an annual or lifetime maximum plan benefit  
5 or similar provision under the plan; or

6 (2) use the cost of rehabilitative or habilitative  
7 therapies described by Section 1367.205(a) as the sole  
8 justification for:

9 (A) increasing plan premiums; or

10 (B) terminating the insured's or enrollee's  
11 participation in the plan.

12 SECTION 8. Section 1367.204(b), Insurance Code, is  
13 repealed.

14 SECTION 9. Subchapter E, Chapter 1367, Insurance Code, as  
15 amended by this Act, applies only to a health benefit plan  
16 delivered, issued for delivery, or renewed on or after January 1,  
17 2018. A health benefit plan delivered, issued for delivery, or  
18 renewed before January 1, 2018, is governed by the law as it existed  
19 immediately before the effective date of this Act, and that law is  
20 continued in effect for that purpose.

21 SECTION 10. This Act takes effect September 1, 2017.
