- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. The heading to Section 30.010, Civil Practice
- 7 and Remedies Code, is amended to read as follows:

- 9 FROM DISCOVERY BY INMATE OR COMMITTED PERSON.
- 10 SECTION 2. Sections 30.010(a) and (b), Civil Practice and
- 11 Remedies Code, are amended to read as follows:
- 12 (a) Personal identifying information pertaining to an
- 13 individual, including the individual's home address, home
- 14 telephone number, and social security account number, is privileged
- 15 from discovery by an individual who is imprisoned or confined in any
- 16 correctional facility or civilly committed as a sexually violent
- 17 predator under Chapter 841, Health and Safety Code, if the
- 18 individual to whom the information pertains is:
- 19 (1) an employee of any correctional facility; [or]
- 20 (2) <u>an officer or employee of the Texas Civil</u>
- 21 Commitment Office or a person who contracts with the office to
- 22 perform a service or an employee of that person; or
- 23 (3) related within the first degree by consanguinity
- 24 or affinity to an individual described by Subdivision (1) or (2)

- 1 [who is an employee of any correctional facility].
- 2 (b) Personal identifying information that is privileged
- 3 under this section may be discovered by an individual who is
- 4 imprisoned or confined in a correctional facility or civilly
- 5 committed as a sexually violent predator under Chapter 841, Health
- 6 and Safety Code, only if:
- 7 (1) the incarcerated individual or committed person
- 8 shows good cause to the court for the discovery of the information;
- 9 and
- 10 (2) the court renders an order that authorizes
- 11 discovery of the information.
- 12 SECTION 3. Article 2.13, Code of Criminal Procedure, is

- 17 SECTION 48. Sections 22.01, 22.11, 38.11, and 46.035, Penal
- 18 Code, as amended by this Act, apply only to an offense committed on
- 19 or after the effective date of this Act. An offense committed
- 20 before the effective date of this Act is governed by the law in
- 21 effect on the date the offense was committed, and the former law is
- 22 continued in effect for that purpose. For purposes of this section,
- 23 an offense was committed before the effective date of this Act if
- 24 any element of the offense occurred before that date.
- 25 SECTION 49. The members of the board of the Texas Civil
- 26 Commitment Office serving on the effective date of this Act may draw
- 27 lots or use another method to determine the members who shall serve

- 1 terms that expire as provided by Section 420A.002(c), Government
- 2 Code, as amended by this Act, in 2019, 2021, or 2023, respectively.
- 3 The members of the board appointed to succeed the members serving on
- 4 the effective date of this Act shall serve six-year terms.
- 5 SECTION 50. This Act takes effect September 1, 2017.
