- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 503.001, Transportation Code, is amended
- 6 by amending Subdivisions (4) and (9) and adding Subdivision (10-a)
- 7 to read as follows:
- 8 (4) "Dealer" means a person who regularly and actively
- 9 buys, sells, or exchanges vehicles at an established and permanent
- 10 location. The term includes a franchised motor vehicle dealer, an
- 11 independent motor vehicle dealer, an independent mobility motor
- 12 vehicle dealer, [and] a wholesale motor vehicle dealer, and a
- 13 manufacturer motor vehicle dealer.
- 14 (9) "Independent motor vehicle dealer" means a dealer
- 15 other than a franchised motor vehicle dealer, an independent
- 16 mobility motor vehicle dealer, [or] a wholesale motor vehicle
- 17 dealer, or a manufacturer motor vehicle dealer.
- 18 <u>(10-a) "Manufacturer motor vehicle dealer" means a</u>
- 19 manufacturer who, at an established and permanent location,
- 20 regularly and actively buys, sells, or exchanges motor vehicles of
- 21 <u>a line make the manufacturer manufactures, distributes, or</u>
- 22 assembles.
