(a) The district has the rights, powers, privileges, 17 functions, and duties: 18 (1) provided by general law <u>applicable to a municipal</u> utility district created under Section 59, Article XVI, Texas 19 Constitution, including Chapters 49, 50, and 54, Water Code; 20 21 (2) relating to a road district or road utility district created under Section 52, Article III, Texas Constitution; 22 23 and 24 (3) relating to the provision of potable and

1 <u>nonpotable water to the residents and businesses of Travis and Hays</u>
2 <u>Counties, including the construction, acquisition, operation, and</u>

5 <u>59, Article XVI, Texas Constitution</u>].

6 (b) Notwithstanding Subsection (a), the district may not 7 construct, acquire, operate, or maintain a toll road.

8 SECTION 3. (a) The legal notice of the intention to 9 introduce this Act, setting forth the general substance of this 10 Act, has been published as provided by law, and the notice and a 11 copy of this Act have been furnished to all persons, agencies, 12 officials, or entities to which they are required to be furnished 13 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 14 Government Code.

(b) The governor, one of the required recipients, has submitted the notice and Act to the Texas Commission on Province Provinc

The Texas Commission on Environmental Quality has filed 18 (c) 19 its recommendations relating to this Act with the governor, the 20 lieutenant governor, and the speaker of the house of representatives within the required time. 21

(d) All requirements of the constitution and laws of this
state and the rules and procedures of the legislature with respect
to the notice, introduction, and passage of this Act are fulfilled
and accomplished.

26 SECTION 4. This Act takes effect immediately if it receives 27 a vote of two-thirds of all the members elected to each house, as

provided by Section 39, Article III, Texas Constitution. If this
 Act does not receive the vote necessary for immediate effect, this
 Act takes effect September 1, 2017.
