The juvenile board shall hold regular meetings on dates 12 (d) set by the board and special meetings at the call of the chairman. 13 [The Nolan County Commissioners Court, the Sweetwater City 14 Commission, and the board of trustees of the Sweetwater Independent 15 School District may agree to provide the funds for the salaries of 16 17 the personnel assigned to Nolan County and the other expenses the board chairman certifies as necessary to provide adequate juvenile 18 services to Nolan County.
