- (1) an electric utility or a power generation company
- 14 as defined by Section 31.002, Utilities Code;

- 18 Section 51.002, Utilities Code; or

- 16 <u>facilities</u>, or services that primarily benefit that area or
- 17 property and do not generally and directly benefit the district as a
- 18 whole.
- 19 Sec. 7982.302. PROCEDURE FOR ELECTION. (a) Before the
- 20 district may impose an ad valorem tax or issue bonds payable from ad
- 21 valorem taxes of the defined area or designated property, the board
- 22 shall hold an election in the defined area or in the designated
- 23 property only.
- 24 (b) The board may submit the issues to the voters on the same
- 25 ballot to be used in another election.
- Sec. 7982.303. DECLARING RESULT AND ISSUING ORDER. (a) If
- 27 a majority of the voters voting at the election approve the

- 1 proposition or propositions, the board shall declare the results
- 2 and, by order, shall establish the defined area and describe it by
- 3 metes and bounds or designate the specific property.
- 4 (b) A court may not review the board's order except on the
