6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subtitle F, Title 6, Special District Local Laws
8	Code, is amended by adding Chapter 7983 to read as follows:
9	CHAPTER 7983. DRIFTWOOD MUNICIPAL UTILITY DISTRICT NO. 1
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 7983.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the district's board of directors.
13	(2) "Commission" means the Texas Commission on
14	Environmental Quality.
15	(3) "Director" means a board member.
16	(4) "District" means the Driftwood Municipal Utility
17	District No. 1.
18	Sec. 7983.002. NATURE OF DISTRICT. The district is a
19	municipal utility district created under Section 59, Article XVI,
20	Texas Constitution.
21	Sec. 7983.003. CONFIRMATION AND DIRECTORS' ELECTION
22	REQUIRED. The temporary directors shall hold an election to
23	confirm the creation of the district and to elect five permanent
24	directors as provided by Section 49.102, Water Code.

- 1 Sec. 7983.004. CONSENT OF MUNICIPALITY REQUIRED. The
- 2 temporary directors may not hold an election under Section 7983.003
- 3 until:
- 4 (1) each municipality in whose corporate limits or
- 5 extraterritorial jurisdiction the district is located has
- 6 consented by ordinance or resolution to the creation of the
- 7 district and to the inclusion of land in the district; and
- 8 (2) the district and each municipality in whose
- 9 corporate limits or extraterritorial jurisdiction the district is
- 10 located have executed an agreement concerning the creation and
- 11 operation of the district.
- 12 Sec. 7983.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a)
- 13 The district is created to serve a public purpose and benefit.
- 14 (b) The district is created to accomplish the purposes of:
- 15 (1) a municipal utility district as provided by
- 16 general law and Section 59, Article XVI, Texas Constitution; and
- 17 (2) Section 52, Article III, Texas Constitution, that
- 18 relate to the construction, acquisition, improvement, operation,
- 19 or maintenance of macadamized, graveled, or paved roads, or
- 20 improvements, including storm drainage, in aid of those roads.
- 21 <u>(c) All land and other property included in the district</u>
- 22 will benefit from the improvements and services to be provided by
- 23 the district under powers conferred by Sections 52 and 52-a,
- 24 Article III, and Section 59, Article XVI, Texas Constitution, and
- 25 other powers granted under this chapter.
- 26 (d) The creation of the district is in the public interest
- 27 and is essential to further the public purposes of:

1	(1) developing and diversifying the economy of the
2	state;
3	(2) eliminating unemployment and underemployment;
4	(3) developing or expanding transportation and
5	commerce; and
6	(4) providing quality residential housing.
7	(e) The district will:
8	(1) promote the health, safety, and general welfare of
9	residents, employers, potential employees, employees, visitors,
10	and consumers in the district, and of the public;
11	(2) provide needed funding for the district to
12	preserve, maintain, and enhance the economic health and vitality of
13	the district territory as a residential community and business
14	<pre>center; and</pre>
15	(3) promote the health, safety, welfare, and enjoyment
16	of the public by providing pedestrian ways and by landscaping,
17	removing graffiti from, and developing certain areas in the
18	district, which are necessary for the restoration, preservation,
19	and enhancement of scenic beauty.
20	(f) Pedestrian ways along or across a street, whether at
21	grade or above or below the surface, and street lighting, street
22	landscaping, vehicle parking, and street art objects are parts of
23	and necessary components of a street and are considered to be an
24	improvement project that includes a street or road improvement.
25	Sec. 7983.006. INITIAL DISTRICT TERRITORY. (a) The
26	district is initially composed of the territory described by
27	Section 2 of the Act enacting this chapter.

(b) The boundaries and field notes contained in Section 2 of 1 the Act enacting this chapter form a closure. A mistake made in the 2 3 field notes or in copying the field notes in the legislative process does not affect the district's: 4 5 (1) organization, existence, or validity; 6 (2) right to issue any type of bond for the purposes 7 for which the district is created or to pay the principal of and 8 interest on a bond; 9 (3) right to impose a tax; or 10 (4) legality or operation. SUBCHAPTER B. BOARD OF DIRECTORS 11 Sec. 7983.051. GOVERNING BODY; TERMS. (a) The district is 12 governed by a board of five elected directors. 13 14 (b) Except as provided by Section 7983.052, directors serve 15 staggered four-year terms. 16 Sec. 7983.052. TEMPORARY DIRECTORS. (a) On or after 17 September 1, 2017, the owner or owners of a majority of the assessed value of the real property in the district may submit a petition to 18 19 the commission requesting that the commission appoint as temporary directors the five persons named in the petition. The commission 20 shall appoint as temporary directors the five persons named in the 21 22 petition. 23 (b) Temporary directors serve until the earlier of: 24 (1) the date permanent directors are elected under

- 1 Section 7983.003 and the terms of the temporary directors have
- 2 expired, successor temporary directors shall be appointed or
- 3 reappointed as provided by Subsection (d) to serve terms that
- 4 expire on the earlier of:
- 5 (1) the date permanent directors are elected under
- 6 Section 7983.003; or
- 7 (2) the fourth anniversary of the date of the
- 8 appointment or reappointment.
- 9 (d) If Subsection (c) applies, the owner or owners of a
- 10 majority of the assessed value of the real property in the district
- 11 may submit a petition to the commission requesting that the
- 12 commission appoint as successor temporary directors the five
- 13 persons named in the petition. The commission shall appoint as
- 14 successor temporary directors the five persons named in the
- 15 petition.
- SUBCHAPTER C. POWERS AND DUTIES
- 17 Sec. 7983.101. GENERAL POWERS AND DUTIES. The district has
- 18 the powers and duties necessary to accomplish the purposes for
- 19 which the district is created.
- Sec. 7983.102. MUNICIPAL UTILITY DISTRICT POWERS AND
- 21 DUTIES. The district has the powers and duties provided by the
- 22 general law of this state, including Chapters 49 and 54, Water Code,
- 23 applicable to municipal utility districts created under Section 59,
- 24 Article XVI, Texas Constitution.
- 25 <u>Sec. 7983.103. WATER CONSERVATION FACILITIES. The district</u>
- 26 may provide for the conservation of water, including by means of the
- 27 construction, operation, and maintenance of a water conservation

- 1 <u>facility or water reuse project.</u>
- 2 Sec. 7983.104. AUTHORITY FOR ROAD PROJECTS. Under Section
- 3 52, Article III, Texas Constitution, the district may design,
- 4 acquire, construct, finance, issue bonds for, improve, operate,
- 5 maintain, and convey to this state, a county, or a municipality for
- 6 operation and maintenance macadamized, graveled, or paved roads, or
- 7 improvements, including storm drainage, in aid of those roads.
- 8 Sec. 7983.105. ROAD STANDARDS AND REQUIREMENTS. (a) A road
- 9 project must meet all applicable construction standards, zoning and
- 10 subdivision requirements, and regulations of each municipality in
- 11 whose corporate limits or extraterritorial jurisdiction the road
- 12 project is located.
- 13 (b) If a road project is not located in the corporate limits
- 14 or extraterritorial jurisdiction of a municipality, the road
- 15 project must meet all applicable construction standards,
- 16 <u>subdivision requirements</u>, and regulations of each county in which
- 17 the road project is located.
- 18 <u>(c) If the state will maintain and operate the road, the</u>
- 19 Texas Transportation Commission must approve the plans and
- 20 specifications of the road project.
- 21 Sec. 7983.106. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE
- 22 OR RESOLUTION. The district shall comply with all applicable
- 23 requirements of any ordinance or resolution that is adopted under
- 24 Section 54.016 or 54.0165, Water Code, and that consents to the
- 25 <u>creation of the district or to the inclusion of land in the</u>
- 26 district.
- 27 <u>Sec. 7983.107.</u> <u>DIVISION OF DISTRICT.</u> (a) The district may

1 be divided into two or more new districts only if: 2 (1) the district has no outstanding bonded debt; and 3 (2) the district is not imposing ad valorem taxes. (b) This chapter applies to any new district created by the 4 5 division of the district, and a new district has all the powers and duties of the district. 6 7 (c) Any new district created by the division of the district 8 may not, at the time the new district is created, contain any land outside the area described by Section 2 of the Act enacting this 9 10 chapter. 11 (d) The board, on its own motion or on receipt of a petition 12 signed by the owner or owners of a majority of the assessed value of the real property in the district, may adopt an order dividing the 13 14 district. 15 (e) The board may adopt an order dividing the district before or after the date the board holds an election under Section 16 17 7983.003 to confirm the creation of the district. (f) An order dividing the district shall: 18 19 (1) name each new district; (2) include the metes and bounds description of the 20 territory of each new district; 21 22 (3) appoint temporary directors for each new district; 23 and 24 (4) provide for the division of assets and liabilities 25 between or among the new districts.

- Sec. 7983.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The
- 15 <u>district may issue</u>, without an election, bonds and other
- 16 <u>obligations secured by:</u>
- 17 (1) revenue other than ad valorem taxes; or
- 18 (2) contract payments described by Section 7983.153.
- 19 (b) The district must hold an election in the manner
- 20 provided by Chapters 49 and 54, Water Code, to obtain voter approval
- 21 before the district may impose an ad valorem tax or issue bonds
- 22 payable from ad valorem taxes.
- 23 <u>(c) The district may not issue bonds payable from ad valorem</u>
- 24 taxes to finance a road project unless the issuance is approved by a
- 25 vote of a two-thirds majority of the district voters voting at an
- 26 election held for that purpose.
- 27 <u>Sec. 7983.152.</u> <u>OPERATION AND MAINTENANCE TAX.</u> (a) If

- 1 <u>authorized at an election held under Section 7983.151</u>, the district
- 2 may impose an operation and maintenance tax on taxable property in
- 3 the district in accordance with Section 49.107, Water Code.
- (b) The board shall determine the tax rate. The rate may not
- 5 <u>exceed the rate approved at the election.</u>
- 6 Sec. 7983.153. CONTRACT TAXES. (a) In accordance with
- 7 Section 49.108, Water Code, the district may impose a tax other than
- 8 an operation and maintenance tax and use the revenue derived from
- 9 the tax to make payments under a contract after the provisions of
- 10 the contract have been approved by a majority of the district voters
- 11 voting at an election held for that purpose.
- 12 (b) A contract approved by the district voters may contain a
- 13 provision stating that the contract may be modified or amended by
- 14 the board without further voter approval.
- SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS
- 16 Sec. 7983.201. AUTHORITY TO ISSUE BONDS AND OTHER
- 17 OBLIGATIONS. The district may issue bonds or other obligations
- 18 payable wholly or partly from ad valorem taxes, impact fees,
- 19 revenue, contract payments, grants, or other district money, or any
- 20 combination of those sources, to pay for any authorized district
- 21 <u>purpose.</u>
- Sec. 7983.202. TAXES FOR BONDS. At the time the district
- 23 issues bonds payable wholly or partly from ad valorem taxes, the
- 24 board shall provide for the annual imposition of a continuing
- 25 direct ad valorem tax, without limit as to rate or amount, while all
- 26 or part of the bonds are outstanding as required and in the manner
- 27 provided by Sections 54.601 and 54.602, Water Code.

(a) The legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished under Section 59, Article XVI, Texas Constitution, and Chapter 313, Government Code.
- (b) The governor, one of the required recipients, has submitted the notice and Act to the Texas Commission on Environmental Quality.
- (c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, the lieutenant governor, and the speaker of the house of

- 1 representatives within the required time.
- 2 (d) All requirements of the constitution and laws of this
- 3 state and the rules and procedures of the legislature with respect
- 4 to the notice, introduction, and passage of this Act are fulfilled
- 5 and accomplished.
- 6 SECTION 4. (a) If this Act does not receive a two-thirds
- 7 vote of all the members elected to each house, Subchapter C, Chapter
- 8 7983, Special District Local Laws Code, as added by Section 1 of
- 9 this Act, is amended by adding Section 7983.108 to read as follows:
- 10 Sec. 7983.108. NO EMINENT DOMAIN POWER. The district may
- 11 not exercise the power of eminent domain.
- 12 (b) This section is not intended to be an expression of a
- 13 legislative interpretation of the requirements of Section 17(c),
- 14 Article I, Texas Constitution.
- SECTION 5. This Act takes effect September 1, 2017.
