H.B. No. 4321

A BILL TO BE ENTITLED

AN ACT

1  
2 relating to the creation of Harris County Improvement District No.  
3 25; providing authority to levy an assessment, impose a tax, and  
4 issue bonds.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Subtitle C, Title 4, Special District Local Laws  
7 Code, is amended by adding Chapter 3958 to read as follows:

8 CHAPTER 3958. HARRIS COUNTY IMPROVEMENT DISTRICT NO. 25

9 SUBCHAPTER A. GENERAL PROVISIONS

10 Sec. 3958.001. DEFINITIONS. In this chapter:

11 (1) "Board" means the district's board of directors.

12 (2) "County" means Harris County.

13 (3) "Director" means a board member.

14 (4) "District" means the Harris County Improvement  
15 District No. 25.

16 Sec. 3958.002. CREATION AND NATURE OF DISTRICT. The  
17 district is a special district created under Section 59, Article  
18 XVI, Texas Constitution.

19 Sec. 3958.003. PURPOSE; DECLARATION OF INTENT. (a) The  
20 creation of the district is essential to accomplish the purposes of  
21 Sections 52 and 52-a, Article III, and Section 59, Article XVI,  
22 Texas Constitution, and other public purposes stated in this  
23 chapter. By creating the district and in authorizing the county and  
24 other political subdivisions to contract with the district, the

1 legislature has established a program to accomplish the public  
2 purposes set out in Section 52-a, Article III, Texas Constitution.

3 (b) The creation of the district is necessary to promote,  
4 develop, encourage, and maintain employment, commerce,  
5 transportation, housing, tourism, recreation, the arts,  
6 entertainment, economic development, safety, and the public  
7 welfare in the district.

8 (c) This chapter and the creation of the district may not be  
9 interpreted to relieve the county from providing the level of  
10 services provided as of the effective date of the Act enacting this  
11 chapter to the area in the district. The district is created to  
12 supplement and not to supplant county services provided in the  
13 district.

14 Sec. 3958.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)  
15 The district is created to serve a public use and benefit.

16 (b) All land and other property included in the district  
17 will benefit from the improvements and services to be provided by  
18 the district under powers conferred by Sections 52 and 52-a,  
19 Article III, and Section 59, Article XVI, Texas Constitution, and  
20 other powers granted under this chapter.

21 (c) The creation of the district is in the public interest  
22 and is essential to further the public purposes of:

23 (1) developing and diversifying the economy of the  
24 state;

25 (2) eliminating unemployment and underemployment; and

26 (3) developing or expanding transportation and  
27 commerce.

1       (d) The district will:

2           (1) promote the health, safety, and general welfare of  
3 residents, employers, potential employees, employees, visitors,  
4 and consumers in the district, and of the public;

5           (2) provide needed funding for the district to  
6 preserve, maintain, and enhance the economic health and vitality of  
7 the district territory as a community and business center;

8           (3) promote the health, safety, welfare, and enjoyment  
9 of the public by providing pedestrian ways and by landscaping and  
10 developing certain areas in the district, which are necessary for  
11 the restoration, preservation, and enhancement of scenic beauty;  
12 and

13           (4) provide for water, wastewater, drainage, road, and  
14 recreational facilities for the district.

15       (e) Pedestrian ways along or across a street, whether at  
16 grade or above or below the surface, and street lighting, street  
17 landscaping, parking, and street art objects are parts of and  
18 necessary components of a street and are considered to be a street  
19 or road improvement.

20       (f) The district will not act as the agent or  
21 instrumentality of any private interest even though the district  
22 will benefit many private interests as well as the public.

23       Sec. 3958.005. INITIAL DISTRICT TERRITORY. (a) The  
24 district is initially composed of the territory described by  
25 Section 2 of the Act enacting this chapter.

26       (b) The boundaries and field notes contained in Section 2 of  
27 the Act enacting this chapter form a closure. A mistake in the

1 field notes or in copying the field notes in the legislative process  
2 does not affect the district's:

3 (1) organization, existence, or validity;

4 (2) right to issue any type of bonds for the purposes  
5 for which the district is created or to pay the principal of and  
6 interest on the bonds;

7 (3) right to impose or collect an assessment or tax; or

8 (4) legality or operation.

9 Sec. 3958.006. APPLICABILITY OF MUNICIPAL MANAGEMENT  
10 DISTRICTS LAW. Except as otherwise provided by this chapter,  
11 Chapter 375, Local Government Code, applies to the district.

12 Sec. 3958.007. CONSTRUCTION OF CHAPTER. This chapter shall  
13 be liberally construed in conformity with the findings and purposes  
14 stated in this chapter.

15 SUBCHAPTER B. BOARD OF DIRECTORS

16 Sec. 3958.051. GOVERNING BODY; TERMS. (a) The district is  
17 governed by a board of five voting directors who serve staggered  
18 terms of four years, with two or three directors' terms expiring  
19 June 1 of each odd-numbered year.

20 (b) The board by resolution may change the number of voting  
21 directors on the board only if the board determines that the change  
22 is in the best interest of the district. The board may not consist  
23 of fewer than five or more than nine voting directors.

24 Sec. 3958.052. APPOINTMENT OF VOTING DIRECTORS. The Texas  
25 Commission on Environmental Quality shall appoint voting directors  
26 from persons recommended by the board.

27 Sec. 3958.053. NONVOTING DIRECTORS. The board may appoint

1 nonvoting directors to serve at the pleasure of the voting  
2 directors.

3 Sec. 3958.054. QUORUM. For purposes of determining the  
4 requirements for a quorum of the board, the following are not  
5 counted:

6 (1) a board position vacant for any reason, including  
7 death, resignation, or disqualification;

8 (2) a director who is abstaining from participation in  
9 a vote because of a conflict of interest; or

10 (3) a nonvoting director.

11 Sec. 3958.055. COMPENSATION. A director is entitled to  
12 receive fees of office and reimbursement for actual expenses as  
13 provided by Section 49.060, Water Code. Sections 375.069 and  
14 375.070, Local Government Code, do not apply to the board.

15 Sec. 3958.056. INITIAL VOTING DIRECTORS. (a) On or after  
16 the effective date of the Act enacting this chapter, the owner or  
17 owners of a majority of the assessed value of the real property in  
18 the district according to the most recent certified tax appraisal  
19 roll for the county may submit a petition to the Texas Commission on  
20 Environmental Quality requesting that the commission appoint as  
21 initial voting directors the five persons named in the petition.  
22 The commission shall appoint the five persons named in the petition  
23 as initial directors by position.

24 (b) Of the initial directors, the terms of directors  
25 appointed for positions one through three expire June 1, 2019, and  
26 the terms of directors appointed for positions four and five expire  
27 June 1, 2021.

1 (c) Section 3958.052 does not apply to this section.

2 (d) This section expires September 1, 2021.

3 SUBCHAPTER C. POWERS AND DUTIES

4 Sec. 3958.101. GENERAL POWERS AND DUTIES. The district has  
5 the powers and duties necessary to accomplish the purposes for  
6 which the district is created.

7 Sec. 3958.102. IMPROVEMENT PROJECTS AND SERVICES. The  
8 district may provide, design, construct, acquire, improve,  
9 relocate, operate, maintain, or finance an improvement project or  
10 service using any money available to the district, or contract with  
11 a governmental or private entity to provide, design, construct,  
12 acquire, improve, relocate, operate, maintain, or finance an  
13 improvement project or service authorized under this chapter or  
14 Chapter 375, Local Government Code.

15 Sec. 3958.103. DEVELOPMENT CORPORATION POWERS. The  
16 district, using money available to the district, may exercise the  
17 powers given to a development corporation under Chapter 505, Local  
18 Government Code, including the power to own, operate, acquire,  
19 construct, lease, improve, or maintain a project under that  
20 chapter.

21 Sec. 3958.104. NONPROFIT CORPORATION. (a) The board by  
22 resolution may authorize the creation of a nonprofit corporation to  
23 assist and act for the district in implementing a project or  
24 providing a service authorized by this chapter.

25 (b) The nonprofit corporation:

26 (1) has each power of and is considered to be a local  
27 government corporation created under Subchapter D, Chapter 431,

1 Transportation Code; and

2 (2) may implement any project and provide any service  
3 authorized by this chapter.

4 (c) The board shall appoint the board of directors of the  
5 nonprofit corporation. The board of directors of the nonprofit  
6 corporation shall serve in the same manner as the board of directors  
7 of a local government corporation created under Subchapter D,  
8 Chapter 431, Transportation Code, except that a board member is not  
9 required to reside in the district.

10 Sec. 3958.105. AGREEMENTS; GRANTS. (a) As provided by  
11 Chapter 375, Local Government Code, the district may make an  
12 agreement with or accept a gift, grant, or loan from any person.

13 (b) The implementation of a project is a governmental  
14 function or service for the purposes of Chapter 791, Government  
15 Code.

16 Sec. 3958.106. LAW ENFORCEMENT SERVICES. To protect the  
17 public interest, the district may contract with a qualified party,  
18 including the county, to provide law enforcement services in the  
19 district for a fee.

20 Sec. 3958.107. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The  
21 district may join and pay dues to a charitable or nonprofit  
22 organization that performs a service or provides an activity  
23 consistent with the furtherance of a district purpose.

24 Sec. 3958.108. ECONOMIC DEVELOPMENT. (a) The district may  
25 engage in activities that accomplish the economic development  
26 purposes of the district.

27 (b) The district may establish and provide for the

1 administration of one or more programs to promote state or local  
2 economic development and to stimulate business and commercial  
3 activity in the district, including programs to:

- 4 (1) make loans and grants of public money; and
- 5 (2) provide district personnel and services.

6 (c) The district may create economic development programs  
7 and exercise the economic development powers provided to  
8 municipalities by:

- 9 (1) Chapter 380, Local Government Code; and
- 10 (2) Subchapter A, Chapter 1509, Government Code.

11 Sec. 3958.109. PARKING FACILITIES. (a) The district may  
12 acquire, lease as lessor or lessee, construct, develop, own,  
13 operate, and maintain parking facilities or a system of parking  
14 facilities, including lots, garages, parking terminals, or other  
15 structures or accommodations for parking motor vehicles off the  
16 streets and related appurtenances.

17 (b) The district's parking facilities serve the public  
18 purposes of the district and are owned, used, and held for a public  
19 purpose even if leased or operated by a private entity for a term of  
20 years.

21 (c) The district's parking facilities are part of and  
22 necessary components of a street and are considered to be a street  
23 or road improvement.

24 (d) The development and operation of the district's parking  
25 facilities may be considered an economic development program.

26 Sec. 3958.110. ANNEXATION OF LAND. The district may annex  
27 land as provided by Subchapter J, Chapter 49, Water Code.



1       Sec. 3958.111. NO EMINENT DOMAIN POWER. The district may  
2 not exercise the power of eminent domain.

3       SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS; ASSESSMENTS

4       Sec. 3958.151. DISBURSEMENTS AND TRANSFERS OF MONEY. The  
5 board by resolution shall establish the number of directors'  
6 signatures and the procedure required for a disbursement or  
7 transfer of district money.

8       Sec. 3958.152. MONEY USED FOR IMPROVEMENTS OR SERVICES.  
9 The district may acquire, construct, finance, operate, or maintain  
10 any improvement or service authorized under this chapter or Chapter  
11 375, Local Government Code, using any money available to the  
12 district.

13       Sec. 3958.153. PETITION REQUIRED FOR FINANCING SERVICES AND  
14 IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a  
15 service or improvement project with assessments under this chapter  
16 unless a written petition requesting that service or improvement  
17 has been filed with the board.

18       (b) A petition filed under Subsection (a) must be signed by  
19 the owners of a majority of the assessed value of real property in  
20 the district subject to assessment according to the most recent  
21 certified tax appraisal roll for the county.

22       Sec. 3958.154. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)  
23 The board by resolution may impose and collect an assessment for any  
24 purpose authorized by this chapter in all or part of the district.

25       (b) An assessment, a reassessment, or an assessment  
26 resulting from an addition to or correction of the assessment roll  
27 by the district, penalties and interest on an assessment or

1 reassessment, an expense of collection, and reasonable attorney's  
2 fees incurred by the district:

3 (1) are a first and prior lien against the property  
4 assessed;

5 (2) are superior to any other lien or claim other than  
6 a lien or claim for county, school district, or municipal ad valorem  
7 taxes; and

8 (3) are the personal liability of and a charge against  
9 the owners of the property even if the owners are not named in the  
10 assessment proceedings.

11 (c) The lien is effective from the date of the board's  
12 resolution imposing the assessment until the date the assessment is  
13 paid. The board may enforce the lien in the same manner that the  
14 board may enforce an ad valorem tax lien against real property.

15 (d) The board may make a correction to or deletion from the  
16 assessment roll that does not increase the amount of assessment of  
17 any parcel of land without providing notice and holding a hearing in  
18 the manner required for additional assessments.

19 Sec. 3958.155. TAX AND ASSESSMENT ABATEMENTS. The district  
20 may designate reinvestment zones and may grant abatements of a tax  
21 or assessment on property in the zones.

22 SUBCHAPTER E. TAXES AND BONDS

23 Sec. 3958.201. ELECTIONS REGARDING TAXES AND BONDS. (a)  
24 The district may issue, without an election, bonds, notes, and  
25 other obligations secured by:

26 (1) revenue other than ad valorem taxes; or

27 (2) contract payments described by Section 3958.203.

1       (b) The district must hold an election in the manner  
2 provided by Subchapter L, Chapter 375, Local Government Code, to  
3 obtain voter approval before the district may impose an ad valorem  
4 tax or issue bonds payable from ad valorem taxes.

5       (c) Section 375.243, Local Government Code, does not apply  
6 to the district.

7       (d) All or any part of any facilities or improvements that  
8 may be acquired by a district by the issuance of its bonds may be  
9 submitted as a single proposition or as several propositions to be  
10 voted on at the election.

11       Sec. 3958.202. OPERATION AND MAINTENANCE TAX. (a) If  
12 authorized by a majority of the district voters voting at an  
13 election held in accordance with Section 3958.201, the district may  
14 impose an operation and maintenance tax on taxable property in the  
15 district in accordance with Section 49.107, Water Code, for any  
16 district purpose, including to:

17               (1) maintain and operate the district;

18               (2) construct or acquire improvements; or

19               (3) provide a service.

20       (b) The board shall determine the tax rate. The rate may not  
21 exceed the rate approved at the election.

22       (c) Section 49.107(h), Water Code, does not apply to the  
23 district.

24       Sec. 3958.203. CONTRACT TAXES. (a) In accordance with  
25 Section 49.108, Water Code, the district may impose a tax other than  
26 an operation and maintenance tax and use the revenue derived from  
27 the tax to make payments under a contract after the provisions of

1 the contract have been approved by a majority of the district voters  
2 voting at an election held for that purpose.

3 (b) A contract approved by the district voters may contain a  
4 provision stating that the contract may be modified or amended by  
5 the board without further voter approval.

6 Sec. 3958.204. AUTHORITY TO BORROW MONEY AND TO ISSUE BONDS  
7 AND OTHER OBLIGATIONS. (a) The district may borrow money on terms  
8 determined by the board. Section 375.205, Local Government Code,  
9 does not apply to a loan, line of credit, or other borrowing from a  
10 bank or financial institution secured by revenue other than ad  
11 valorem taxes.

12 (b) The district may issue bonds, notes, or other  
13 obligations payable wholly or partly from ad valorem taxes,  
14 assessments, impact fees, revenue, contract payments, grants, or  
15 other district money, or any combination of those sources of money,  
16 to pay for any authorized district purpose.

17 (c) The limitation on the outstanding principal amount of  
18 bonds, notes, and other obligations provided by Section 49.4645,  
19 Water Code, does not apply to the district.

20 Sec. 3958.205. TAXES FOR BONDS. At the time the district  
21 issues bonds payable wholly or partly from ad valorem taxes, the  
22 board shall provide for the annual imposition of a continuing  
23 direct annual ad valorem tax, without limit as to rate or amount,  
24 for each year that all or part of the bonds are outstanding as  
25 required and in the manner provided by Sections 54.601 and 54.602,  
26 Water Code.

1           SUBCHAPTER F. MUNICIPAL ANNEXATION AND DISSOLUTION

2           Sec. 3958.251. MUNICIPAL ANNEXATION; DISSOLUTION. (a) The  
3 district is a "water or sewer district" under Section 43.071, Local  
4 Government Code.

5           (b) Section 43.075, Local Government Code, applies to the  
6 district.

7           (c) Section 375.264, Local Government Code, does not apply  
8 to the dissolution of the district by a municipality.

9           SECTION 2. Harris County Improvement District No. 25  
10 initially includes all territory contained in the following area:

11           TRACT 1 - 88.03 ACRES

12           FIELD NOTES of a 88.03 of an acre tract of land situated in  
13 the H.T. & B. R.R. Survey, Block 3, Sec. 9, Abstract No. 421, the  
14 H.T. & B. R.R. Survey, Block 3, Sec. 7, Abstract No. 903 the C.  
15 Collis Survey, Abstract No. 1330, and the G. Lolley Survey,  
16 Abstract No. 1410 Harris County, Texas; said 88.03 of an acre tract  
17 of land being out of and a part of Restricted Reserve "A" of the  
18 Westside Mall, Sec. 2 and recorded at Film Code No. (F.C. No.)  
19 602144 of the Harris County Map Records (H.C.M.R.); said 88.03 of an  
20 acre tract of land being more particularly described by metes and  
21 bounds as follows:

22           NOTE: All bearings are Lambert Grid bearings and all  
23 coordinates refer to the Texas State Plane Coordinate System, South  
24 Central Zone (#4204), as defined by article 21.071 of the Natural  
25 Resources Code of the State of Texas, 1983 Datum (2001 adjustment).  
26 All distances are actual distances. Scale factor = 0.99989325287.

27           BEGINNING at a found 5/8" iron rod with cap stamped "E.H.R.A.

1 713-784-4500" for the Southeast intersection of Partnership Way  
2 (80' right-of-way) and Grand Circle Boulevard (80' right-of-way) as  
3 recorded at F.C. No. 446143 of the H.C.M.R.

4 THENCE N 30°52'03" W with the common West line of said  
5 Restricted Reserve "A" and across said Grand Circle Boulevard a  
6 distance of 80.00 feet to a set 5/8" iron rod with cap stamped  
7 "E.H.R.A. 713-784-4500" for the Northwest corner of this tract of  
8 land and being in the North right-of-way line of the proposed Grand  
9 Circle Boulevard (80' right-of-way).

10 THENCE N 59°07'57" E with the common North right-of-way line  
11 of said Grand Circle Boulevard and the North line of this tract of  
12 land a distance of 22.95 feet to a set 5/8" iron rod with cap stamped  
13 "E.H.R.A. 713-784-4500" for the beginning of a curve to the right.

14 THENCE in a Northeasterly direction with the common North  
15 right-of-way line of said Grand Circle Boulevard, the North line of  
16 this tract of land and said curve to the right having a central  
17 angle of 42°04'54", a radius of 340.00 feet, a length of 249.72 feet,  
18 and a chord bearing and distance of N 80°10'24" E, 244.14 feet to a  
19 set 5/8" iron rod with cap stamped "E.H.R.A. 713-784-4500" for the  
20 end of this curve.

21 THENCE S 78°47'08" E with the common North right-of-way line  
22 of said Grand Circle Boulevard and the North line of this tract of  
23 land a distance of 183.98 feet to a set 5/8" iron rod with cap  
24 stamped "E.H.R.A. 713-784-4500" for the beginning of a curve to the  
25 left.

26 THENCE in a Southeasterly direction with the common North  
27 right-of-way line of said Grand Circle Boulevard, the North line of

1 this tract of land and said curve to the left having a central angle  
2 of  $12^{\circ}30'52''$ , a radius of 260.00 feet, a length of 56.79 feet, and a  
3 chord bearing and distance of  $S 85^{\circ}02'35'' E$ , 56.68 feet to a set  $5/8''$   
4 iron rod with cap stamped "E.H.R.A. 713-784-4500" for the end of  
5 this curve.

6 THENCE  $N 88^{\circ}42'07'' E$  with the common North right-of-way line  
7 of said Grand Circle Boulevard and the North line of this tract of  
8 land a distance of 522.00 feet to a set  $5/8''$  iron rod with cap  
9 stamped "E.H.R.A. 713-784-4500" for the beginning of a curve to the  
10 right.

11 THENCE in a Southeasterly direction with the common North  
12 right-of-way line of said Grand Circle Boulevard, the North line of  
13 this tract of land and said curve to the right having a central  
14 angle of  $24^{\circ}56'38''$ , a radius of 340.00 feet, a length of 147.82 feet  
15 and a chord bearing and distance of  $S 78^{\circ}50'34'' E$ , 146.66 feet to a  
16 set  $5/8''$  iron rod with cap stamped "E.H.R.A. 713-784-4500" for the  
17 beginning of a reverse curve to the left.

18 THENCE in a Northeasterly direction with the common North  
19 right-of-way line of said Grand Circle Boulevard, the North line of  
20 this tract of land and said reverse curve to the left having a  
21 central angle of  $92^{\circ}17'27''$ , a radius of 25.00 feet, a length of 40.27  
22 feet and a chord bearing and distance of  $N 67^{\circ}28'02'' E$ , 36.05 feet to  
23 a set  $5/8''$  iron rod with cap stamped "E.H.R.A. 713-784-4500" for the  
24 Northeast corner of this tract of land and the end of said reverse  
25 curve to the left; said point being the Southwest intersection of  
26 Westside Way (80' right-of-way) as recorded at F.C. No. 602144 of  
27 the H.C.M.R. and said Grand Circle Boulevard.

1           THENCE S 21°19'19" W with the Northeast line of this tract of  
2 land a distance of 5.27 feet to a set 5/8" iron rod with cap stamped  
3 "E.H.R.A. 713-784-4500" for the beginning of a curve to the left.

4           THENCE in a Southeasterly direction with the common  
5 Southwesterly right-of-way line of said Grand Circle Boulevard, the  
6 Easterly line of this tract of land and said curve to the left  
7 having a central angle of 87°40'44", a radius of 105.00 feet, a  
8 length of 160.68 feet and a chord bearing and distance of S 22°31'03"  
9 E, 145.45 feet to a found 5/8" iron rod with cap stamped "E.H.R.A.  
10 713-784-4500" for the beginning of a reverse curve to the right.

11           THENCE in a Southeasterly direction with the Southwesterly  
12 right-of-way line of said Grand Circle Boulevard, the Easterly line  
13 of this tract of land and said reverse curve to the right having a  
14 central angle of 09°46'53", a radius of 1500.00 feet, a length of  
15 256.08 feet and a chord bearing and distance of S 61°27'59" E, 255.77  
16 feet to a found 5/8" iron rod with cap stamped "E.H.R.A.  
17 713-784-4500" for the end of this reverse curve.

18           THENCE S 56°34'32" E with the Southwesterly right-of-way line  
19 of said Grand Circle Boulevard and the Easterly line of this tract  
20 of land a distance of 187.17 feet to a found 5/8" iron rod with cap  
21 stamped "E.H.R.A. 713-784-4500" for the beginning of a curve to the  
22 right.

23           THENCE in a Southeasterly direction with the Southwesterly  
24 right-of-way line of said Grand Circle Boulevard, the Easterly line  
25 of this tract of land and said curve to the right having a central  
26 angle of 13°05'36", a radius of 570.00 feet, a length of 130.26 feet  
27 and a chord bearing and distance of S 50°01'44" E, 129.98 feet to a



1 found 5/8" iron rod with cap stamped "E.H.R.A. 713-784-4500" for  
2 the beginning of a compound curve to the right.

3       THENCE in a Southeasterly direction with the Westerly  
4 right-of-way line of said Grand Circle Boulevard, the Easterly line  
5 of this tract of land and said compound curve to the right having a  
6 central angle of  $42^{\circ}11'03''$ , a radius of 470.00 feet, a length of  
7 346.04 feet and a chord bearing and distance of  $S 22^{\circ}23'24'' E$ , 338.28  
8 feet to a found 5/8" iron rod with cap stamped "E.H.R.A.  
9 713-784-4500" for the end of this compound curve.

10       THENCE  $S 01^{\circ}17'53'' E$  with the Westerly right-of-way line of  
11 said Grand Circle Boulevard and the Easterly line of this tract of  
12 land a distance of 468.93 feet to a set 5/8" iron rod with cap

18 introduce this Act, setting forth the general substance of this  
19 Act, has been published as provided by law, and the notice and a  
20 copy of this Act have been furnished to all persons, agencies,  
21 officials, or entities to which they are required to be furnished  
22 under Section 59, Article XVI, Texas Constitution, and Chapter 313,  
23 Government Code.

24           (b) The governor, one of the required recipients, has  
25 submitted the notice and Act to the Texas Commission on  
26 Environmental Quality.

27           (c) The Texas Commission on Environmental Quality has filed

1 its recommendations relating to this Act with the governor,  
2 lieutenant governor, and speaker of the house of representatives  
3 within the required time.

4 (d) The general law relating to consent by political  
5 subdivisions to the creation of districts with conservation,  
6 reclamation, and road powers and the inclusion of land in those  
7 districts has been complied with.

8 (e) All requirements of the constitution and laws of this  
9 state and the rules and procedures of the legislature with respect  
10 to the notice, introduction, and passage of this Act have been  
11 fulfilled and accomplished.

12 SECTION 4. This Act takes effect immediately if it receives  
13 a vote of two-thirds of all the members elected to each house, as  
14 provided by Section 39, Article III, Texas Constitution. If this  
15 Act does not receive the vote necessary for immediate effect, this  
16 Act takes effect September 1, 2017.
