23	creation of the district is essential to accomplish the purposes of

- 4 the Act enacting this chapter form a closure. A mistake in the
- 5 field notes or in copying the field notes in the legislative process
- 6 does not affect the district's:

- 8 (2) right to contract;
- 9 (3) authority to borrow money or issue bonds or other
- 10 obligations described by Section 3795.205 or to pay the principal

- 16 for which the bonds will provide funding, including data, profiles,
- 17 maps, plans, and specifications related to the project; and
- 18 (B) a cash flow analysis to determine the
