HOUSE CONCURRENT RESOLUTION

1 WHEREAS, Texas game wardens devote themselves to the 2 protection of the state's natural resources, and since 1895, 18 of these dedicated public servants have tragically lost their lives 3 while fulfilling their important duties; and 4 5 WHEREAS, Game wardens, as certified peace officers, responsible for preserving the peace and enforcing the game, fish, 6 7 and water safety laws of Texas, which include, but are not limited to, apprehending poachers and other individuals who ignore wildlife 8 9 law; many of the criminals that game wardens encounter have also ventured into other illegal activities, such as theft or the drug 10 11 trade, and because game wardens are often patrolling areas with 12 hunters, loaded guns are a constant in their work; the myriad challenges of the job may put them in harm's way at any time; and 13 14 WHEREAS, To honor those who died in the line of duty, the Texas Game Warden Association erected the Game Warden Memorial at 15 the Texas Freshwater Fisheries Center in Athens; the monument, a 16 bronze, life-sized statue of a warden, is dedicated to the memory of 17 Joe Williams, Harry Raymond, Dawson Richard Murchison, R. M. Wynne, 18 Gus Engeling, Claude Keller, J. D. Murphree, Joe Evans, Lloyd 19 Gustin, Ronnie Germany, James Daughtrey, Barry Decker, Bruce Hill, 20 21 Michael Pauling, Wes Wagstaff, Justin Hurst, Teyran "Ty" Patterson, and George Harold Whatley Jr.; and 22 23 WHEREAS, Many Texans are unaware of the sacrifices made by

- 5 RESOLVED, That the 85th Legislature of the State of Texas
- 6 hereby authorize the State Preservation Board, subject to state law
- 7 and rules of the board, to approve the relocation of the Texas Game
- 8 Warden Memorial to the State Capitol Complex, at a site outside of
- 9 the historic Capitol grounds; and, be it further
- 10 RESOLVED, That the board consider a site south of the Sam
- 11 Houston Building for the location of the memorial; and, be it

- 13 RESOLVED, That the Texas secretary of state forward an
- 14 official copy of this resolution to the executive director of the
- 15 State Preservation Board and to the chair and president of the Texas
- 16 Game Warden Association.
