## HOUSE CONCURRENT RESOLUTION

- 1 WHEREAS, The Texas population is growing rapidly, and the
- 2 number of health care providers is not keeping pace; and
- 3 WHEREAS, Almost 70 percent of Texas counties were wholly or
- 4 partially designated as primary care Health Professional Shortage
- 5 Areas in 2015; and
- 6 WHEREAS, The Texas Legislature and governor approved \$53
- 7 million for graduate medical education funding in the 84th
- 8 Legislative Session to help address this shortage; and
- 9 WHEREAS, Before that investment, the Texas Higher Education
- 10 Coordinating Board projected that, by 2016, more than 100 Texas
- 11 medical school graduates would not have an opportunity to remain in
- 12 state for their residency training due to a lack of first-year
- 13 residency positions; and
- WHEREAS, In 2015, Texas medical schools awarded 1,692 doctor
- 15 of medicine and doctor of osteopathic medicine degrees, and the
- 16 state opened two new medical schools in 2016, and an additional four
- 17 medical schools may be created in the near future; and
- 18 WHEREAS, This new growth in the number of medical school
- 19 graduates will all but nullify or outstrip the legislature's recent
- 20 efforts to expand graduate medical education and further hinder
- 21 Texas' efforts to achieve the goal of 1.1 residency positions for
- 22 each medical school graduate; now, therefore, be it
- 23 RESOLVED, That the 85th Legislature of the State of Texas
- 24 hereby express its support for prioritizing a substantial increase

- 1 in funding for graduate medical education before it considers
- 2 authorizing the creation and support of additional medical schools
- 3 in our state; and, be it further
- 4 RESOLVED, That the Texas Legislature charge the Texas Higher

- 7 graduate medical education; and, be it further
- 8 RESOLVED, That the Texas secretary of state forward an
- 9 official copy of this resolution to all public and private
- 10 institutions of higher education in the state.
