HOUSE CONCURRENT RESOLUTION

- 1 WHEREAS, In recent years, the Gulf of Mexico has contained
- 2 the highest total allowable catch of red snapper in decades, but in
- 3 2016, anglers experienced the shortest recreational fishing season
- 4 to date, lasting less than two weeks; and
- 5 WHEREAS, The U.S. government has overseen the Gulf
- 6 recreational red snapper fishery for nearly four decades; today,
- 7 federal management systems attempt to regulate red snapper fishing
- 8 by the pound with tools specifically designed to manage the
- 9 commercial sector, despite the fact that federal data collection
- 10 systems are incapable of accounting to such a level of specificity
- 11 for recreational harvests; and
- WHEREAS, The U.S. government has, moreover, neglected to use
- 13 recent data to provide meaningful guidelines and requirements for a
- 14 systematic reallocation of federal fisheries; except for minor
- 15 adjustments to account for errors in its own data collection
- 16 system, the Gulf red snapper fishery allocation is based on highly
- 17 suspect data from 1979-1986 and has remained unchanged since 1991;
- 18 and
- 19 WHEREAS, The federal government is currently promoting a
- 20 management strategy to privatize the Gulf red snapper fishery;
- 21 approximately 50 percent of the fishery is already held by private
- 22 businesses, while another 20 percent has been designated to be
- 23 sold; shares of this public resource have also been given away for
- 24 free, based on a commercial operator's past catch history; and

1 WHEREAS, Because of extraordinarily remiss requirements in

2 its conflict of interest guidelines, the federal fisheries

3 management system allows commercial operators who already own red

4 snapper shares or who may be gifted shares to serve on the Gulf of

5 Mexico Fishery Management Council and to cast votes on issues that

6 will result in direct financial benefit for them; and

7 WHEREAS, By creating a prohibitive environment for anglers

8 and ethical issues among user groups and stakeholders, the U.S.

9 government has proved itself incapable of properly managing red

10 snapper fishing in the Gulf of Mexico, and all five states along the

11 Gulf Coast have increasingly needed to implement regulations and

12 seasons that are not consistent with the federal management plan;

14 WHEREAS, Numerous studies, including some funded by NOAA

15 Fisheries, indicate that the greatest economic engine in the Gulf

16 reef fishery is the recreational angling sector, and federal

control should be relinquished to the Gulf states, which depend

18 most on this vital public resource; now, therefore, be it

19 RESOLVED, That the 85th Legislature of the State of Texas

20 hereby encourage Congress to pass legislation or adopt policies

21 allowing Texas to manage the Gulf of Mexico red snapper fishery out

22 to 200 nautical miles; and, be it further

23 RESOLVED, That the Texas secretary of state forward official

24 copies of this resolution to the president of the United States, to

the president of the Senate and to the speaker of the House of

26 Representatives of the United States Congress, and to all the

27 members of the Texas delegation to Congress with the request that
