1 WHEREAS, Former state representative Carl H. Isett retired as

a captain in the United States Navy Reserve on March 6, 2017,

3 drawing to a close an exemplary career in the armed forces that

5 WHEREAS, Carl Isett was commissioned an officer in the U.S.

6 Navy Reserve Supply Corps Program in April 1991, and he went on to

7 graduate from the Basic Qualification Course at the Navy Supply

8 Corps School in Athens, Georgia, in April 1993; his initial

9 assignments included service as an executive officer for the

10 Defense Distribution Depot Oakland Headquarters Unit in Lubbock and

11 as officer in charge for detachments in Lubbock and Austin; and

12 WHEREAS, Captain Isett gained extensive experience in

theater logistics in Southeast Asia, through his participation in

14 exercises in such locations as Thailand and Singapore; in his

15 stateside assignments in the early 2000s, he served as commanding

16 officer of distribution and supply centers in Denver and Oklahoma

17 City, and in his role as commanding officer for Naval Supply

18 Activity Bahrain, Detachment B, in San Antonio, he supported the

19 navy's major logistical hub in the Persian Gulf; and

20 WHEREAS, In 2006, Captain Isett was deployed with the Navy

21 Customs Battalion QUEBEC to serve as executive officer overseeing

22 nearly 400 sailors in Kuwait and Iraq; during his second active duty

23 deployment, from June 2011 to March 2012, he led the Defense

24 Logistics Agency Distribution in Kandahar, Afghanistan, the first

- 2 of war; he subsequently completed additional duty in Denver and in
- 3 San Diego, and he concluded his tenure by serving as the commanding
- 4 officer of Navy Reserve Force Korea, Detachment F, in Fort Worth;

- 6 WHEREAS, This accomplished officer is the recipient of the
- 7 Defense Meritorious Service Medal, the Navy Meritorious Service
- 8 Medal with gold star, the Navy Commendation Medal with gold star,
- 9 and the Navy Achievement Medal with gold star; and
- 10 WHEREAS, A graduate of Texas Tech University, Captain Isett
- 11 holds a bachelor of business administration degree with a double
- 12 major in accounting and finance as well as a master's degree in
- 13 finance; in addition to his service as a reserve officer and as the
- 14 representative for House District 84 in the Texas Legislature from
- 15 1997 to 2010, he has been employed as a certified public accountant
- 16 and a consultant; and
- 17 WHEREAS, Carl Isett's commitment to upholding the highest
- 18 ideals of the U.S. military has earned him the respect and
- 19 admiration of his fellow Texans, and he may indeed reflect with
- 20 considerable pride on his outstanding efforts in behalf of his
- 21 state and nation; now, therefore, be it
- 22 RESOLVED, That the 85th Legislature of the State of Texas
- 23 hereby honor Carl H. Isett on the event of his retirement from the
- 24 U.S. Navy Reserve and commend him for 26 years of distinguished
- 25 military service; and, be it further
