1           WHEREAS, Cherished memories remain to comfort the loved ones  
2 of Betty Ann Peden of Hondo, who passed away on April 26, 2016, at  
3 the age of 75; and

4           WHEREAS, A native of San Antonio, the former Ann Howard was  
5 born on February 10, 1941, to David and Minnie Howard; continuing a  
6 family tradition that reaches back four generations, she pursued a  
7 career as a pharmacist, and after moving to Hondo, she purchased  
8 Windrow Drug Store and operated it as Peden Rexall for some four  
9 decades alongside her husband, Robert Peden; she also went on to  
10 serve members of her profession as president of the Texas State  
11 Board of Pharmacy; and

12           WHEREAS, Earlier in her life, Mrs. Peden worked as a  
13 substitute teacher at the high school and middle school levels; she  
14 had a lively interest in politics as well, having played an  
15 instrumental role in the formation of the Medina County Republican  
16 Party; she was a county chair for over 30 years and a longtime  
17 member of the Texas Republican County Chairman's Association, and  
18 she taught seminars all over the state on the responsibilities of a  
19 county chair and various aspects of election law; and

20           WHEREAS, Mrs. Peden was also a highly regarded member of her  
21 community of faith at First Methodist Church, where she and her  
22 husband sang in the choir, and she was a member and officer of  
23 several organizations, among them the Hondo Garden Club and Sigma  
24 Tau Sorority; above all else, she was a loving wife to her husband

1 of 54 years, a devoted mother to her sons, Scott and James, and a  
2 doting grandmother of four grandchildren, Ashley, Robert, David,  
3 and Ann; and

4 WHEREAS, Admired for her intelligence, her civic engagement,  
5 and her kind and thoughtful nature, Ann Peden will be deeply missed,  
6 and she will forever hold a special place in the hearts of those who  
7 were fortunate enough to know her; now, therefore, be it
