## RESOLUTION

1 WHEREAS, The Irma Lerma Rangel Young Women's Leadership 2 School in Dallas is commemorating in 2016-2017 its 13th year of 3 providing an outstanding education to area youth, and this occasion 4 offers a welcome opportunity to recognize the school as well as its 5 namesake, the Honorable Irma Rangel; and

6 WHEREAS, Opened in the Oak Lawn neighborhood in the fall of 7 2004, the Irma Lerma Rangel Young Women's Leadership School is a 8 magnet program of the Dallas Independent School District; the first 9 all-girls public school in Dallas, it was established so that 10 teachers could tailor their instruction to the particular ways in 11 which girls learn; and

12 WHEREAS, Through leadership seminars, weekly advisory and partnerships with 13 meetings, educational and cultural 14 organizations, the school provides students with a rigorous college-preparatory course of study; 15 the project-oriented 16 curriculum emphasizes math, science, and technology but also offers 17 ample learning opportunities in foreign languages and humanities; in addition to equipping students with an excellent academic 18 foundation, the school encourages its youth to develop a strong 19 20 sense of ethics and civic responsibility and to become leaders in 21 their community; and

22 WHEREAS, It is fitting that such an admirable and progressive 23 institution be named for Irma Rangel, a trailblazer who worked 24 tirelessly as a member of the Texas Legislature to improve the

1 state's public school and higher education systems; an educator 2 herself early in her career, Ms. Rangel taught for 14 years in 3 Texas, California, and Venezuela before earning a degree from St. 4 Mary's University School of Law in 1969; after clerking for a 5 federal district judge and serving as an assistant district 6 attorney, she returned to her hometown of Kingsville in 1973 to 7 practice law; and

8 WHEREAS, When Ms. Rangel won a seat in the Texas House of Representatives in 1976, she became the first Hispanic woman 9 10 elected to the state legislature; elected to 14 consecutive terms, she was the fifth most-senior member of this body at the time of her 11 12 death in 2003; during her tenure, she sponsored legislation 13 establishing а pharmacy school for Texas A&M 14 University--Kingsville, now known as the Irma Lerma Rangel College 15 of Pharmacy; and

16 WHEREAS, The first Mexican American woman to be appointed 17 chair of a house committee, Representative Rangel was named chair 18 of the House Committee on Higher Education in 1995, and she served 19 in that role for four consecutive legislative sessions; she was 20 also the first woman elected chair of the Mexican American 21 Legislative Caucus and the first Mexican American to receive the 22 G. J. Sutton Award from the Legislative Black Caucus; and

WHEREAS, A passionate advocate for the poor, the marginalized, and the underserved, Irma Rangel was a true Texas pioneer who worked tirelessly to make a college education accessible to all citizens, and her life serves as a shining example for the outstanding young women who are attending the school that

1 bears her name; now, therefore, be it

2 RESOLVED, That the House of Representatives of the 85th Texas 3 Legislature hereby pay tribute to the accomplished and inspiring 4 life of the Honorable Irma Rangel and commend the students of the 5 Irma Lerma Rangel Young Women's Leadership School on the 13th 6 anniversary of the opening of that academy; and, be it further
